



# Letters to The Point

#### Still More on the Lord's Prayer

To The Editors of the Point:

My wish is to respond to the comments of Steve C. on "Reconsidering the Lord's Prayer" [July 2001 issue] - yet, a close review of this letter deals mainly with the first 2 words of that prayer, without any indication that he has gone beyond these 2 words and studied or critiqued the text of the remainder of this useful prayer. You will agree, I hope, that a discussion on just those first 2 words, to the exclusion of the rest of the text, would be futile. [As an aside, however, we could point out that it was Associate Justice of the Supreme Court, Oliver W. Holmes, who uttered the statement: "My religion is summed up in the first two words of the Lord's Prayer". ] I also find little point in discussing or denigrating a prayer because of its origin - following this approach would eliminate many of the "formal" prayers that we utter, not to mention many of the phrases that currently sprinkle American idiomatic speech.

My preference, however, is to address the question posed by the writer: "Why would we need to take a second look at this prayer beloved of so many?" Part of the answer is in the question itself - it is, in fact "...beloved of so many" - but this appeal to a great majority seems not to have impressed the writer. So, to carry the response to his question beyond that phrase requires that we venture beyond the first 2 words and study the rest of the 7 statements of the Lord's Prayer.

My "second look" discloses that this prayer, on close reflection, can meet the needs of everyone on his or her level at whatever stage of spiritual development he or she has reached. The stunning revelation of this "second look" is the ability of this prayer to address specific and integral components of the AA recovery program [steps and slogans] with uncanny precision and foresights. Some examples:

#### FROM THE PRAYER: FROM THE PROGRAM

"Our Father" -This is Step 2 - coming to

believe in a power greater than ourselves - a sine qua non of further growth in the

program

"Thy will be done"

-In its briefest form, this is
Step 3, the surrender to our

Higher Power.

"Give us THIS DAY our"... -From Day One in the program we are told to live One

Day at a time, to worry only about the needs of today - whether for bread, for sobriety, for resources Implicitly in Step 5 and

explicitly in the Step 9, we are seeking forgiveness -

and [see next bullet:]

"as we forgive those who trespass against us..."

-This is the rest of the Step 8 and 9 process [and I have found that I am incapable of forgiving and accepting forgiveness except by the grace of God, which I am seeking-which I MUST seek in prayer.

"Lead us not into temptation"

-Practicing these principles in all our affairs" demands that I avoid several pitfalls along the way; I fall into many traps because of persisting character defects - whose removal requires God's grace - once again, a gift for which I must ask.

Folks, this is my "second look"- and I must ask: how many prayers can you find that contain so many of the principles of the AA recovery program in the 7 simple statements of the Lord's Prayer? - and, not to exalt the obvious, prayer IS one of the important maintenance steps of this "happy road of destiny"!

Do we have the arrogance to tell God to "forgive us our trespasses, as we forgive those who trespass against us"? I think we should humbly ask Him to help us forgive those who trespass against us, as HE forgives US.

Then we go and tell him not to lead us into temptation - implying that He is capable of leading us into it at one time or another. God will never lead his children into temptation. I think that a better way to pray would be to ask Him to keep us away from temptation, or not to let us fall into it.

#### Cost of the Central Office Move - in a Nutshell

Many members know the IFB is near the end of a long, oneyear process of moving the Central Office. But understanding the finances involved with this is little more difficult. The brief summary below may help clarify things.

Moving the Central Office from Market St. to Sacramento St. has involved spending a lot of time - and a fair amount of money. This is primarily because we found an ideal space that was reasonably priced, in a very good location - but one that required some interior construction to make it workable. Chief among this work was the installation of a small elevator to make the space wheelchair accessible.

The board, through its Lease Committee, decided this was close to perfect. The inexpensive price was no doubt related to the space's 'non-wheelchair-accessible' status - and the fact that it's an 'odd space' in some ways, i.e., it's a small store-front office with no contiguous space to 'grow' into - a problem for many commercial ventures, but perfect for us. Our office has been about the same size for decades, and in AA, we don't want a big office. And while we don't have a lot of money, we do have a lot of very dedicated volunteers who were willing to give prodigious amounts of time to the process of making this work.

And so a deal was stuck. We came up with a budget for the project. The bottom line (including a \$6600 refundable deposit


and the necessity of paying 'double rent' for 2 months), will come in around \$54,000 - but wait! \$26,000 of that amount is being reimbursed by our new landlord. Gratitude Month funds from last year have been set aside for this purpose and amount to about \$18,000. This leaves about \$10,000 that needs to be funded from operating cash. (which we do have - barely! Our prudent reserve will remain intact).

God provides, if we do the footwork!

## A Trip to the GSO

If you ever get the chance to go to New York, please stop by our General Service Office, located on the 11th floor of 475 Riverside on the upper west side in Manhattan. There is a big meeting there every Friday at 11a.m. followed by a group tour of our GSO. Assistants to the staff are available anytime to take visitors on a tour. I met some staff members, including our Director, Greg.

The tours traditionally end with an introduction to the Archives Room. This part of the tour ought not be glossed over. Plan to spend some time in this room. I had a photo taken of me sitting on the brown leather reupholstered couch that sat in Bill's office. There is a photo on the wall behind the couch of Bill and his secretary - and the couch!

In the first Archives room, you will find lots of large gray file cabinets lining the walls. You can ask for help to go through them if you wish. There's a glass display case with past editions of the Big Book and another book case with copies of our literature in other languages. The back room holds several large scrap books full of newspaper articles about our fellowship. There is also, interestingly enough, a whole wall of books about alcoholism and related subjects, several of them autographed.

Our meeting in print, a.k.a. the Grapevine, is located on the floor below. I got to meet the new editor! He gave me a copy of the November issue that contains a story about a member who escaped the WTC disaster with his life. Confused and dusted by the destruction, the member ends up at a meeting! Also moving are the hard copy of all the issues since it's inception, along with a typed catalog of topics in each issue. Oddly, the catalog was open to 'Navy', were I was reminded that our fellowship has many a member who served on the front lines in past world wars while they stayed sober!

I am filled with lots of hope that in our fellowship, we have accessible, timeless, experience and strength to draw from - no matter what circumstances we might find our selves facing today.

## **Open For Business**

From the A.A. Grapevine, October, 2001. Reprinted with permission.

It was probably 1975 when the secretary of our regular Thursday evening meeting asked if I would substitute for him on Thanksgiving so he could visit his family out of town. Of course, I said I would, and did, which led to a memorable event.

In those days the secretary had single-handed responsibility for everything about the meeting - setup, refreshments, literature, speaker, collection - the works. About half an hour before meeting time, I unlocked and began the preliminaries. Then, as now, the meeting was held in a local church in our small town a few miles north of San Francisco. Then, as now, it was called the "Original Marin Smokeless Group" of Alcoholics Anonymous. Those who can recall that era will realize that a nonsmoking group then was a pioneer adventure. Attendance since the group's founding several years earlier had always been modest, averaging about eight to ten members. I didn't expect a large crowd at 8:00pm on that Thanksgiving Day, but I dutifully made preparations for the usual turnout.

The chairs were in place, Coffee was ready. Literature was laid out on the table in the back of the room. The "AA Meeting" sign was hanging outside the door.

The clock showed 8:05pm; then 8:15.

No one had showed up.

I sat reading to myself from the Big Book. I put it down for a moment and wondered what to do.

Then a young woman came shyly through the door. "Hi" she said quietly. "Is this the AA meeting?

"It is. And you are welcome."

She was a professional musician and had a gig at a watering hole in Sausalito, a couple miles away. She was a long way from home and needed a meeting. We had a great one right there, just the two of us. The regular Thursday night meeting of "Original Marin Smokeless Group" was open for business that Thanksgiving evening a quarter of a century ago.

#### TRADITION ELEVEN

#### ATTRACTION / PROMOTION

Tradition Eleven (short form) states: "Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio, and films."

Long Form: "Our relations with the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not be broadcast, filmed, or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need to praise ourselves. We feel it better to let our friends recommend us.

Any member may cloak himself with all the anonymity he wants. However, full names may be used within A.A. and in person-to-person contact outside of A.A. Members should avoid such titles as "A.A.Counselor". A. A. members may speak in the media only if names and faces are not revealed; only if they are speaking solely as individual members – not for A.A.

Dr. Bob is reported to have said that there were two ways to break the anonymity tradition: one, by giving one's name at the public level; two, by being so anonymous that one could not be reached by other drunks.

In May, 1940, the first anonymity break at the public level took place. Although this did attract many to A.A., it was a challenge to our slowly emerging principle of anonymity. Other widely publicized breaks took place. Despite immediate gains, it was eventually felt that to publicize one's A.A. membership, and then to drink again, would jeopardize A.A.'s survival.

Anonymity breaks (at the local level) are handled by our Public Information/Cooperation with the Professional Community Committee (PI/CPC).

Our Hospitals and Institutions Committee (H&I), to its credit, is opposed to sensationalism. It reminds A.A. speakers to avoid off-color jokes, profanity and other forms of self indulgence when speaking at A.A. meetings within a facility.

It is recorded that if a member used bad language at an A.A. meeting, Dr. Bob would say, "You have a very good head, young man, but it would be more effective if you cleaned it up a bit."

The founders of A.A. were "buried just like other folks". i.e., no monument, no reference to Alcoholics Anonymous – only a simple headstone.

# Time in a Bottle

Time marches on - and yet another local Oldtimer is gone. May his experience strength and hope live forever.


My D. Day was Jan 2, 1945. I had promised my wife, children and relatives I would never drink again after January 1, 1945. However I was drunk Christmas Eve, Christmas Day and every day during the holidays. On January 1st I went to the East West game at Kezar Stadium in San Francisco... About thirty of us from the Ford dealership went.

We all had a bottle. I don't remember too much of the game. I blacked out before halftime and don't remember getting home. Jan 2, 3, 4, I did remain sober, with a BAD hangover. January 4th I was dying for a bottle but I had to be baby sitter for my 1 year old daughter. Sober and sick... There was knock on the door. The person there said he was from AA and his name was Ray H.... (since deceased). Thinking he was from AAA Auto Insurance, I invited him in. He explained that he had received a letter from me asking for help for my problem with alcohol. He showed me the letter which was signed with my name (found out my wife had sent it and signed my name). I told him that I had not signed the letter and had not sent it. He mentioned that while he was there he would like to tell me about his problem with alcohol, and what the program of AA has meant to him with his three years of sobriety. I thought what a bunch of B-S-! No one can stay sober for three years! Ray then talked about his problems with drinking. In many ways his drinking problems were much like my own. He talked for an hour or so, then started to

leave. I asked "What do you do to continue your sobriety?" He mentioned that there were meetings once a week for members and added the only requirement for membership is a desire to stop drinking. He asked if I would like to go to a meeting? I said yes. He then asked if I could go the next 24 hours without drinking? I replied I

don't really know, but I will try. Ray called me the next evening and asked how I had made out. I mentioned I was seriously wanting to buy a bottle but did not and have not had a drink since I had last seen him. The words he said then I will never forget; "Les, you have made a very good start." Thanks to God and AA, I have never had a drink since.



My first AA meeting was January 10, 1945 at the *only* meeting in San Francisco at that time. It was at a blind alley called Harlen Place off Grant Avenue. I was told it had been a speakeasy during Prohibition. There were about 24 people there, about five of them women. I was told this was the only meeting in San Francisco at this time but there was a meeting once a week in Palo Alto, one in Oakland, one in Sacramento and also one in San Quentin Prison (the prison meeting was handled by the San Francisco and Oakland Groups).

There were no telephone listings - only PO Box No.'s at the old Mission St. Post Office. That's how Ray received the letter written by my wife. Thank God for that letter!

ANONYMITY was absolute. There was no such thing as an *open meeting*. I was personally interrogated by some of the "old timers". Old Timers meant you were sober for 2 or 3 years. I was only 32 years old and they didn't see how I could be a genuine alcoholic at that tender age. Some of the Old Timers I met are listed in AA Comes of Age, page 88-89. John C., the oldest, Fred and Amye C., OK and Juanita P., Ray H. (my sponsor), Nic C., Warren T., Vic M., Ray P., Dave D., and more.

After I was sober for about six weeks

and gone to our San Francisco weekly meetings, OK P. asked me to go with him and three others to San Quentin Prison for an AA meeting with the prisoners. He promised, "You will not have to talk." There we met Warden Clinton Duffy, a really great guy. He invited us to lunch at the prison dining room. From there we went to the meeting room for an AA meeting with the prisoners. Boy was I surprised; there were at least twice as many members in prison as there were in our San Francisco group. OK called on a couple to give a pitch, and they got a big hand. Then he said, "We have a young man sober for about a month, let's hear from him. Give the kid a big hand." I think I had a double heart attack, two hemorrhages and a nervous breakdown!! I have no idea what I said at that meeting, but OK said I did good. Ho! Ho! Yeah!

I did meet some terrific guys. The record shows that 80% of the prisoners that were members of AA in prison never returned (to prison)...

#### Are contributions to AA tax-deductible?

The answer to this is yes ... and no.

The following is from A.A. Guidelines - Finance (published by the A.A. General Service Office)

"Contributions to an A.A. Group, Central Office, or intergroup are tax-deductible only if the entity is a qualified charitable organization as determined by the Internal Revenue Service.

Contributions made directly to the General Service Board of A.A. are deductible under Section 501(c)(3) of the Internal Revenue Code.

The Internal Revenue Code has no provision under which the General Service Board of A.A. could apply for tax-exempt status for all groups and other A.A. entities, since each entity is autonomous in financial matters, as in all other ways. Donations at A.A. groups are not deductible unless the group has filed the proper I.R.S. office and has obtained a ruling that the organization is tax-exempt. Experience has shown that some tax examiners may make exceptions if proof of contributions is presented, but this is strictly up to the individual tax examiner..."

As the Intercounty Fellowship (our local Intergroup) is also an incorporated non-profit (501c3), your Gratitude Month contribution **is** tax-deductible *if* you write out a check payable to the Central Office and give it to your treasurer to be included with your group's Gratitude Month donation (or mail it directly to the office). Cash contributions in the hat would almost certainly not qualify.

- A. Review of Agenda: The agenda was approved.
- **B.** Review of Minutes: The minutes of the August 2001 regular meeting were accepted with the following changes: 1) Ken Y. was present, 2) Ardis J. would prefer different language in part of the Lease Committee report. Per discussion and retraction of other alternate version, the 8/2001 minutes reflect the wording used in the meeting recap summary published in the Point.

#### C. IFB Reports

CHAIR'S REPORT: Bob B., Chair, reviewed the general procedure for placing items for discussion on the agenda, which is to contact Bob B. or Mark M (Central Office Manager), or preferably both, at least several days before the upcoming IFB meeting and make the request.

**TREASURER'S REPORT:** Pat M. presented the treasurer's report, including a balance sheet for July, 2001, and the Profit & Loss budget statement for January – July, 2001. Pat noted that current YTD figures show a net profit of \$7515.30.

#### **CENTRAL OFFICE MANAGER'S REPORT:**

**General:** Mark M., Interim Manager, submitted a written report, including current volunteer shifts available. Mark also noted that the draft of the Internal Controls Review is back from Steven Price, CPA, and will be discussed at the next COC meeting.

Action Item: The fact that the cost of the new 4th Edition of the Big Book to Central Office will be discounted by \$1 (for a limited time) generated extensive and lengthy discussion of the policies and procedures for book sales in our Central Office. We have traditionally tried to resell books to local groups at near cost (unlike many other Intergroups, which derive greater profit

from book sales—for example, it was stated that San Mateo charges \$7.20 per Big Book). The focus of discussion was whether or not to pass this temporary \$1 savings per book along to the groups (by temporarily discounting the cost of the new 4th Edition). Also discussed were the various obvious and hidden costs to the Central Office involved in the purchase, reselling, and storage of AA Conference approved literature. A motion to table further discussion and decision for 1 month fell short of a majority (14 Yes, 14 No), and after further discussion it was voted (17 yes, 4 No, 5 Abstaining) to sell the new 4<sup>th</sup> Edition of the Big Book at the current price (currently \$6 per individual hard cover edition) with current quantity discounts unchanged as well. A further motion to publish an informational/explanatory article in the Point was voted down (9 Yes, 17 No, 2 Abstaining). Over 1 hour of orderly questions, discussion, and votes were devoted to this item.

D. Central Office Committee: Patrick C. reporting. Stu S. and Smithy B. are members of the COC Human Resources sub-committee, looking into how to proceed with the search for candidates for Central Office Manager. Other COC activity reported included discussion of costs and needs of dual insurance coverage as operations transfer to the new office space, and also the process of obtaining bids for a network consultant.

#### E. Ad Hoc Committee reports:

- \* Website: Smithy B. (Chair) reported good progress in updating/improving our on-line presence. Ideas are solicited from the fellowship at large. A flier contained an error and a corrected version will be got out to IFB members.
- \* **ByLaws Review**: Alex H. reported. Committee has begun to meet regularly on the 3<sup>rd</sup> Wednesday of each month at Central Office and will be bringing issues to the IFB for review in future months.
- \* Point Editorial Committee. Patrick C. reported briefly. The upcoming "Marin section" in the October Point was noted.
- \* Orientation Committee. Kade H. reported. Another orientation session was held last month. One new member at tended. These information presentations will continue to be offered ad hoc.
- \* Literature Review Committee. No report.
- \* Special Needs Committee. Jeff T. (Chair) reported. Committee members have agreed to conduct research into various questions regarding special needs of deaf and hearing-impaired members. There was discussion of a document the Central Office manager might use as a notification and reminder to groups requesting new or ongoing help with ASL..
  - \* Budget, Graphics, and 12<sup>th</sup> Step Committees have not yet met.
- \* Archives Committee. Stu S. (Chair) reported briefly. There followed some discussion regarding the purpose and intent of the Archives Committee.
  - \* Moving Committee has not yet met.
- \* Marin Logistics Committee. Reginald J. will be acting chair. It was brought up by Jim D. that (due to an over sight) Star of the Sea had not been paid for our last meeting there. Mark M. reports that is already being rectified ("The check is in the mail"). As October arrangements for a Marin site were still not firm it was agreed without dissention or further discussion to postpone the next Marin IFB meeting to November.
- \* Lease Committee did not make a formal report to the IFB this month. (As reported in the September, 2001 Point, the lease on the new office has been signed and submitted.)


