

# AA FEVER - CATCH IT! By Bill S.

I'm seven years sober now, but I'll never forget the baseball game I attended at one year of sobriety down in Los Angeles at Dodger Stadium with five other guys in the program. The Dodgers were hosting the Chicago Cubs that particular day. As soon as we arrived we stocked up on Dodger Dogs with copious condiments, cheese nachos, chips, fries, the usual healthy fare, and paraded to our seats in the first row of level three high up behind home plate.

As the game got underway for the crowd of 32,500, I ate my Dodger Dogs, drank my Coke, and ate a quarter pound of peanuts (a few days before the game my sober buddy Andy made a special trek into downtown L.A. to buy several pounds of jumbo monster unsalted peanuts—nothing but the best for an alcoholic!).

During the fifth inning I was telling the guy next to me, who had 18 years in the program at the time, how much I was enjoying myself—how just a little over a year before I never would have left my room to do anything like this. In fact, before I entered the unit and sobered up at St. John's Hospital (May 5th '95), the only two places I made excursions to were my job and the liquor store. I had quit shopping for food. My sole meals were supplied compliments of Domino's Pizza in less than thirty minutes. Domino's was the only phone number I had on my speed dialer and the pizza delivery boys fought to bring me pizzas because when I was drunk I over tipped. I had long since stopped going out to movies, the beach, book and music stores, etc. And dating? Forget it. The last thing I wanted was somebody criticizing my drinking. Socializing was the last thing on my mind. I lived like a hermit in my bedroom, watching TV while single-handedly trying to keep the third shift working overtime at the Miller Brewing Company. Pathetic? You betcha!

Anyway, I was explaining to my new A.A. buddy how grateful I was to be at the ball game and sober when suddenly—a loud WHACK caught everybody's attention (except for mine, since I was engaged in "serious" alcoholic conversation).

There was a mad scramble and fans converged all around me as a pop fly came hurtling right where we were sitting. The baseball bounced off the empty seat over to my right between Jack and Jim, who skir-

mished for the ball along with a dozen other guys. Jim thought it went into Andy's bag of peanuts and dived inside. Jumbo unsalted nuts exploded into the air.

That's when I glanced down at my feet. The ball had rolled right to me! I merely reached down, grabbed it and stood up. Grinning victoriously I held the ball aloft for all to see amid mucho envious cursing.

I tried to give the ball to Jack E. since he's such a great Cubs fan but he would have no part of it. "This ball was meant for you!" insisted Jack, who had over three decades in the program and once actually met cofounder Bill W. Jack continued by explaining that maybe this was God's way of telling me that as long as I was sober and willing to leave my room (and take Domino's off my speed-dialer), every once in a while my Higher Power would toss me a ball. In fact, God had probably wanted to toss me a lot of balls in the past but I had been holed up in my room drinking, afraid to go out into the world—I had taken myself out of the game.

Bottom line: I can't catch pop flies if I don't show up for the baseball game. And if I don't continue to stay sober and venture out into the world I'll be blind to untold opportunities. Drinking will only rob me of the good things my Higher Power wants to send my way.

As we left the stadium, one of the guys asked me how many baseball games I had been to. I told him that baseball wasn't my sport and this was the first time I had actually gone to a game. He sighed mightily and shook his head in exasperation, "I've been to hundreds of games and never once caught a ball! You show up to see your first game and out of 32,000 fans you get it!"

Is it odd or is it God? Frankly, I quit asking myself that question when I got sober.

All of my A.A. baseball cohorts signed the ball that day and it rests today in a prominent space on the shelf above my computer as I write this to remind me to acquire more balls in sobriety.

By the way, the Dodgers lost to the Cubbies 6-4

# ON PUBLIC SPEAKING IN SOBRIETY: ADVENTURES WITH THE "PI" COMMITTEE

When I first came through the doors of Alcoholics Anonymous, I had no intention of joining the Public Information/Cooperation with the Professional Community (PI/CPC) Committee. In fact, when I was new, PI was the furthest thing from my mind. This Committee provides speakers to non-A.A. groups who are interested in learning about Alcoholics Anonymous. They regularly send volunteers to "drunk driving" classes and public school classes to talk about A.A. I never received a DUI, and I do not have any children. In addition, I am scared to death of public speaking. Nevertheless, a number of years ago, I found myself signing up with PI in order to carry the A.A. message to non-alcoholics. Clearly, my Higher Power had something in mind for me that I could never have envisioned for myself.

Since "telling your story" is part of the A.A. program, when I put together some time in the rooms, I realized that I was not exempt from this suggestion. When asked, in absolute terror, I attempted to share the story of my experience, strength, and hope. The result was always the same. I was miserable from the moment I agreed to speak, until the day I had to share. On that dreaded day, I would babble incoherently, and watch with horror, as half the people in the room got up and left "for coffee". Those who remained would be staring at the ceiling or at their watches, and the poor newcomers attending the meeting would gaze at me with glazed over eyes. It was a totally humiliating experience every time I told my story.

I attempted to "turn it over" and make "conscious contact" with my Higher Power, but public speaking made me nearly unconscious with fright. Over time, it became clear that I had absolutely no tools for making a coherent presentation before an audience. Left to my own devices, I would probably wind up in an institution, or dead from stage fright. I finally hit a bottom around public speaking, and once again I realized that I was powerless, truly powerless over my own fear.

I started asking my Higher Power for help to carry the message. That help came to me in the form of a young woman named Patricia who told me about PI. She said PI was helping her overcome her fear of public speaking. I learned that the Committee holds "speaker workshops" several times a year; and that they offer tips for effective speaking. There is an opportunity for new members to observe other, more seasoned volunteers to see how they make presentations. When you are actually scheduled to speak, you are teamed up with an experienced speaker,

so you don't have to do it alone. I wanted what they had. And so I did what they did.

And what I learned was much more than just how to be an effective speaker. I learned through my commitment with this Committee, that I could face my fears in order to grow. PI/CPC gave me an opportunity, each time I spoke, to practice letting go and letting G-d. It has brought me closer to my Higher Power.

As my program became more about service and less about self, I began to understand that standing in front of a group of people was not really about me at all, but rather about carrying the message of A.A. to an audience. It became clear that what I was talking about was far more important than what people thought about me. The "fear of people" began to leave me. As my anxiety about public speaking lessened, my gratefulness to the program continued to grow. And my commitment in PI/CPC, has become a way to show my gratitude to Alcoholics Anonymous by carrying the A.A. message.

Participation in committee work also gave me an opportunity to meet members of the Fellowship that I might not have gotten to know by only attending regularly scheduled meetings. The people that have been my partners at various PI "gigs" have always shown me kindness and respect. Sometimes, when you "click" with your partner as a team, there can be a spirit of great playfulness between you, which the audience can feel and appreciate.

You also get to know the people who take on additional service work in order to keep the Committee functioning. Besides the usual "trusted servants", there are also volunteers who serve as Workshop Coordinators, and Speaker Schedulers. There is a Media Liaison who works with members of the press and radio. Their work behind the scenes enables PI/CPC to continue to provide the vital work of carrying the message to non-Alcoholics Anonymous groups.

And finally, by being a member of PI, I also got an insider look at some of the organizational aspects of A.A. Watching how the Committee functions internally offers important information about how A.A. business gets done at the group level. The practical application of the Traditions in every day affairs makes the words in the 12&12 come alive in a new way. Especially during these difficult economic times, when people have lost confidence in dealing with large corporations, A.A. is an

# THIS IS HOW IT HAPPENED! How the Message of A.A. Arrived in Cuba in January, 1993

Between 1993 and 2001, a small but dedicated group of A.A. members, most of them from San Francisco and the Bay area, traveled to Cuba, the former USSR and the Peoples' Republic of China to carry the A.A. message to still suffering alcoholics in places where A.A. had not reached.

This letter is "the history of A.A. in Cuba" written by the woman who was instrumental in contacting and organizing the group of A.A. members and arranging their trip. As you can see, the seeds the little group planted have grown and thrived.

Over the next several months, we will try to print articles detailing the intrepid groups other travels on the Happy Road of Destiny.

You asked me to tell you the story of how the message of A.A. arrived in Cuba in January, 1993. I learned about the program of A.A. through a friend about 10 years prior to this date in Syracuse, NY. I remember we were eating donuts and drinking coffee after the Service at Unity Church in Syracuse, and timidly I came over to say hello. As I spoke, the first question I was asked by Marti R. was, where was my English accent from, to which even more timidly I responded: from Cuba. I was surprised to see the brightness in her eyes when she said: from Cuba? How wonderful! From there on I felt very comfortable as if I were home. I could speak about Cuba with someone from the bottom of my heart. I had found a friend.

From Marti R. I learned that A.A. was her spiritual path. What I heard sounded good. As she explained to me the program I learned to accept the Twelve Steps as a way of life, without ever asking myself the reason why it was so important for her to pass on the message. I never thought to relate the program of recovery with alcohol, primarily because I never saw alcohol anywhere in the ten years that later on we shared an apartment in Miami FL, and secondly because I became fascinated with the Twelve Steps. The Twelve Steps of A.A. appeared to me to be logical, rational, well thought, with universal characteristics, good for every body.

I never felt the need to join an Al-Anon group. I went to the A.A. open meetings because I liked the people. The idea of bringing the message of A.A. to Cuba happened on a very hot day of the month of July in one of my trips to Cuba to visit my family. I was walking by a park on Linea Street and saw a man apparently asleep on a steamily hot sidewalk. I wondered what was the matter, and people passing by did not help when realizing the man was drunk. I had never seen before the effects of alcohol so closely. I came back home to Miami with the determination to make the program of recovery of A.A. to be known in Cuba.

With the assurance of having by my side the support of a

well-seasoned, experienced member of A.A., I started talking to my friends from Cuba in transit in Miami about A.A. I sent books with them, and encouraged them to open the doors of their hearts and their churches to meetings for people with problems with alcohol to get together to study the books. By doing this, the idea did not go too far. I thought I should go farther with it.

With the help of my friend and spiritual mentor, Dr. Adolfo Ham, I was able to get an interview with Dr. Silvio Platero, a member of the Office of Religious Affairs of the PCC. I don't remember the date. I left with Dr. Platero the blue book of A.A. and others. I told him that I wanted to invite a pastor from Cuba to spend 30 days in Miami to go to as many A.A. meetings as possible in Spanish. The person I was directed to was the Rev. Juan Francisco Naranjo. The Rev. Naranjo and his wife, the Rev. Estela Hernandez, were very active in community services. I talked to them, and pastor Naranjo accepted my invitation to come to Miami in spite of telling him that I did not have any money to pay for his airfare and expenses. I wrote a letter of invitation to him, and with that he was able to obtain a visa to travel from Cuba to the U.S.

When pastor Naranjo returned to Cuba, he brought with him several books and started A.A. group meetings at his church. Even with this, the idea did not make any progress. Pastor Naranjo was not an alcoholic. The program of recovery only works among alcoholics, sharing, as you say their strengths, hopes and experiences. The Cubans in Miami did not take up the challenge, thinking that they had to wait for the revolution to be over before they could bring the message of A.A. to Cuba.

One day, commenting about my project of bringing the message of A.A. to Cuba with friends from Peacenet, someone sent me an e-mail from South Africa, I don't remember her name, who gave me the phone number and the address of the organization based in San Francisco, CA, USA, "Creating A Sober World". Without waiting long, Bruce K., their coordinator, and I started planning a trip to Cuba with members of this organization. Bruce K. called the Department of State, and there was no need to apply for a special license for the initial group of six people to travel to Cuba. We were received by the Rev. Juan Francisco Naranjo and Estela Hernandez at the Havana airport with free visas. We stayed with them, they provided us with a meeting room, took care of the details of a marvelous program of activities in Cuba that included visits to hospitals and places of treatment for alcoholism. Thus, this is how the first A.A. group "Sueño" started in Cuba at the "William Carey" Baptist Church in January, 1993. I remember bringing Julio to the

# Pacific Regional Forum

My name is Don K. I'm an alcoholic. My home group is Old St. Mary's. I serve on the California Northern Coastal Area of General Service as a District Committee Member for the San Francisco district. I traveled to Phoenix to attend the Pacific Regional Forum. This biennial event represents General Service Areas in Arizona, California, Nevada, Utah, Idaho, Oregon, Washington, Alaska, and Hawaii. A Forum does not conduct business. I arrived on Wednesday July 10<sup>th</sup> and checked in at the Metcalf House, an international hostel, at which I have a life membership. The following day I went to the Arid Club, just six blocks away. There were a few visitors at the meeting who were attending the Forum. As this was not a group consciencemandated activity I paid my own way. The temperature was 108°.

Forum participants registered on Friday with a final count of 724. All members of the fellowship were welcome. New York General Service Office staff were there to answer questions and explain what they do. Pacific Regional Trustees, both past and present, were also in attendance.

The outgoing Pacific Regional Trustee, Jim C., handed over the gavel to the incoming Trustee, Phyllis H. Elaine McDowell, Class A Trustee and Chair of the General Service Board gave the welcome and opening remarks. Trustees spoke on the Role of the Class B Trustee, the Role of the Trustee-At-Large, and the Role of the Class A Trustee. GSO staffers Valerie O'N., Eva S., and Adrienne B. made the following presentations: General Service Staff Assignments; What About Group Services?; and How Regional Forums Came About—the Inside Story. GSO Archivist Judith S. presented on A.A. Archives.

The floor microphones were then opened general sharing and "Ask-it Basket" slips were read. Questions ranging from why San Diego gave money back from the International Convention in 1995 to why we can't order literature directly from GSO over the Internet.

On Saturday morning, one of the members of the fellowship I met at the Arid Club gave me a ride to the Forum; I checked into the Holiday Inn. The day began at 9:00 AM with continental breakfast Presentations on *The A.A. Grapevine/La Vina* were made by a director and editors of the magazines.

The next presentations, made by delegates and alternate delegates, were Selection of Conference Theme Topics; How and Why are Archives Important? The ABCs of Service; and

Rotation–Rotating On. Jo T. from Alaska spoke on Overcoming Geographic Challenges. Later A.A. World Service Director John K. and GSO General Manager Greg M. gave financial presentations.

Workshops opened with Mike *G*. and Mary T. chairing on *Diversity in A.A.* Greg M. chaired another open mike/ask-it-basket followed by the video, *Markings on the Journey*. With that the workshops broke into other rooms.

I attended two workshops, *The A.A. Grapevine: A Valuable Tool* chaired by Raymond M., Grapevine Director and *The Importance of a Home Group: What Defines It and How It Works* chaired by Kathy C. Other concurrent workshops included *Spanish Workshop; Growth of a New Area; Serving Alcoholics with Special Needs; Our Third Legacy; Carrying the Message Behind the Walls; La Vina: A Valuable Tool; A.A. Archives; Remote Communities: A Part of or Apart From; Our Relationships with Our Friends: Cooperation or Affiliation?*; and *Sponsorship: I am Responsible.* 

Sunday morning's session began with Pacific Regional Trustee Phyllis H. answering Ask-It-Basket questions as well as introducing past Pacific Regional Trustees, who shared briefly. The closing remarks by Elaine McDowell, were warm and trusting. The next Pacific Regional Forum will be in Portland, Oregon in 2004.

# Focus on the 12 Concepts

Hello, everyone... summer's almost gone and autumn is on its way. It's September, time for our discussion of Concept Nine:

"Good service leaders, together with sound and appropriate methods of choosing them, are at all levels indispensable for our future functioning

and safety. The primary world service leadership once exercised by the founders of A.A. must necessarily be assumed by the Trustees of the General Service Board of Alcoholics Anonymous."

This concept discusses leadership in A.A. Where does leadership begin? It begins at the group level. The group has the right, as well as the responsibility, to elect its leaders. And, since we're going to apply this to our Marin/San Francisco area, we'll discuss the Intergroup Representative.

The Intergroup Representative is the group's link to and voice in what happens in the Intercounty Fellowship or Intergroup. Each representative, duly elected by his or her group, becomes a member of the IFB, the board of directors for the Intercounty Fellowship. This is important, as the IFB determines the "direction" we take in such significant matters as operation of the Central Office, Bookstore, Website, Teleservice and other functions vital to our fellowship.

Therefore, the Intergroup Representative is a vital position. The more groups that carefully select and send reps to the Board, the better our fellowship will function. The reps the groups elect should be people well-grounded in The Traditions and who are willing and able to perform sometimes difficult and controversial, but always important, service.

An interesting aspect of the discussion regarding this concept in the A.A. Service Manual concerns the responsibility of the elected Trusted Servant in the face of majority opposition. The discussion states in part:

"A 'politico' is an individual who is forever trying to 'get the people what they want'. A statesman is an individual who can carefully discriminate when and when not (emphasis in the original) to do this. He recognizes that even large majorities, when badly disturbed or uninformed, can, once in a while, be dead wrong. When such an occasional situation arises, and something very vital is at stake, it is always the duty of leadership, even when in a small minority, to take a stand against the storm, using its every ability of authority and persuasion to effect a change."

This is powerful stuff! It flies in the face of our A.A. sense of "majority always rules." In 22 years in A.A. service work, I have only had one personal experience wherein I felt I had to "take a



stand against the storm" in a vital issue. It was the most stressful, difficult thing I've ever had to do in all my A.A. service. And, I hope I am never in such a position again. I suppose the fact I've only "been there" once indicates that the situations rarely arise. That is good, both for A.A. and for the trusted servants in leadership positions.

Another interesting passage: "Leadership is often called upon to face heavy and sometimes long-continued criticism. This is an acid test. There are always constructive critics... Then there are those whom we like to call our 'destructive' critics. They power-drive, they are 'politickers', they make accusations. Maybe they are violent, malicious. They pitch gobs of rumors, gossip, and general scuttle-butt to gain their ends—all for the good of A.A., of course! But in A.A. we have at last learned that these folks, who may be a trifle sicker than the rest of us, need not be destructive at all, depending very much on how we relate ourselves to them."

In my experience, there are some of those folks around. And some of them have "influential" positions in A.A. and have an audience for their comments. All I can do is listen and learn, take any valid suggestions, but try to handle the situation with love and tolerance. Sometimes I am better at this than at other times.

Lastly I'll mention "vision," which the Service Manual refers to as "that all-important attribute." The discussion goes on to say the idea of vision in service is not in conflict with our motto of "one day at a time" but, rather, is a necessary element in maintaining a healthy Fellowship.

My personal, relevant experience in this arena has to do with the future of the IFB and its relationship to the Fellowship in Marin and San Francisco Counties. When I became IFB chair, I was well aware that there is much to be done to bring all of us together and encourage widespread participation by the Groups and the individual members. I can't do that alone, but I can hope to share that vision with others, work hard and leave the results in the hands of my Higher Power.

As always, I will close by saying I am *not* an expert on The Concepts. I invite and encourage your input, whether by way of questions, comments or articles of your own. example of how an organization can function effectively, while maintaining respect and dignity for its individual members.

Recently, I had an opportunity to witness first-hand, the vital service PI/PCP provides to the community. The Committee was contacted by a group of ministers from an in-patient facility who were involved in counseling alcoholics. These men and women were religious people, who wanted very much to help their patients. Yet they found themselves frustrated by an inability to effectively communicate with the alcoholics in their care. They wanted speakers from PI/CPC to help them understand the steps and the program of A.A. so that they could use this information to be of service at the facility.

It was difficult to explain to these nice people that they were "powerless" to gain the confidence of an alcoholic. No matter how much they learned about Alcoholics Anonymous, they lacked one essential in-

g r e d i e n t i n gaining the trust of the patients in their care. Because they were not alcoholic themselves, they did not have the ability to relate their own story to the people they wanted to help.

We advised the ministers that they could best be of service to the suffering alcoholic by contacting Central Office and arranging to have someone from the fellowship come to the facility to talk with the patient. After all, sharing our story, one-on-one and at the group level, is what we learn to do in A.A. It's what helps to keep us sober.



I am sure a copy could be made available to you through Arkie K. or Bruce K.

I visited the Office of General Services of A.A. in Havana last December, 2001. Almost ten years after our first visit in 1993, there are almost 100 A.A. groups across the Island of Cuba. I am mystified over the dedication that the offices of general services of A.A. offer to the world and the role every one of its members play locally to make the program work. My message to my friends who still don't know about A.A., or those who perhaps know about it, but are still in doubt, is that they may open the doors of their hearts, their churches and meeting places to the groups of A.A. in Cuba.
