April Fool

The First of April is All Fools' Day, a day traditionally celebrated by mischievous children and adults alike. On this day we play pranks on one another. Sometimes these are elaborate hoaxes and sometimes it's a simple surprise that gives us amusement. One year, as a child, I opened up some teabags and replaced the tea inside with instant coffee. Other similar substitutions I've heard of range from the disgusting-filling the sugar bowl with salt-to the elaborate-spreading rumors in advance to catch the victim with disinformation-to the kindhearted-arranging a surprise visit from a loved friend or relative. The one thing all April Fools' pranks have in common is the element of surprise-the sudden realization that things are not what we thought they were.

My last drink was sometime around five o'clock in the morning on March 31st 1996. I arrived at a meeting still drunk that morning and slowly came to clarity through the day. I went to sleep that night and when I woke up the next morning someone had emptied out my life and replaced it with a new one.

I heard a comedian once say that on April first someone had broken in to his home, stolen everything he owned, and replaced it with an exact replica. That's exactly how I felt that morning. Something had changed, but I could not say what it was or list the missing items on a police report.

As it turns out many things were not what I thought they were. Among the items stolen from me on April first and replaced with a similar-looking replacement were my pride, my independence, and my self-sufficiency.

I thought that March 31st was just the end of my drinking. Then God jumped out from around the corner shouting "April Fool!" The world was not what I had thought it was.

I started to go to meetings (almost) every day and to not drink in between (or during) meetings. It was suggested that I listen to the people with more time sober than myself. I read A.A. literature and took service commitments. People trusted me with the keys to meeting places. My life started to get better and I started to think that I might be starting to understand this strange new world I inhabited.

Approaching my fourth sobriety anniversary, I was still going to meetings, still not drinking in between (or during) meetings, still reading program literature, still listening to people with more time than me. I thought I had a pretty good idea what was going on in my life. I had a good job and a pretty girlfriend. I lived in an apartment with hardwood floors and a view of downtown San Francisco.





The 36th Annual PRAASA conference occurred in Reno, NV the weekend of March 7-9 and was attended by over 1,100 alcoholics from the Pacific Region states - California, Oregon, Washington, Arizona, Nevada, Idaho, Alaska and Hawai'i.

PRAASA, the Pacific Region Alcoholics Anonymous Service Assembly, takes place every year right before the General Service Conference, which is staged every April in New York City. It is not a recovery conference but a service assembly. Though there are a couple of regular AA meetings, most of the conference is spent in panels or roundtables discussing issues that affect local AA service committees as well as AA as a whole.

Delegates from all 17 Pacific Region areas were present as well as the Pacific Region Trustee and three employees from GSO in New York. The rest of the attendees were those in General Service positions such as GSRs and DCMs and those of us representing Intergroups. San Francisco and Marin AA were well

represented at the assembly and we all returned enthusiastic, more informed about service issues and, of course, ever grateful for our blessed sobriety.

During the weekend, we discussed the Grapevine (both English and Spanish language editions) and when/if they will be self-supporting; whether we should put the entire Big Book online on the AA.org website; if we need a new pamphlet on AA, Religion and Spirituality; AA on the internet; how to better cooperate with professionals; and many other topics of interest to AA as a whole.

I was able to attend the Intergroup and Newsletter Roundtable discussions with Maury P., our Central Office Manager. We participated in lively debate and got a few new ideas to bring back to The Point committee. It was invaluable, not to mention fun, for us all.

Spaghetti Feed

Marin Teleservice held its annual Spaghetti Feed this past month and thanks to all the hard work from the "spaghetti committee" and the excellent turnout by the fellowship, the The day started out at 3:30 event was a great success. when the first crew showed up to setup and start cooking. While the sauce cans were being opened and chairs and tables were wheeled out from the closet, 20 pounds of spaghetti were thrown into a pot. Teleservice has learned a thing or two about spaghetti feeds in the nine years they've been doing this; mainly to bring something to stir 20 pounds of spaghetti. Tradition has it that a nine iron was used in the first year to stir the spaghetti and, although that wasn't required this year, there was a nine iron present in the kitchen for the sake of tradition and a good story. By 5:30 everything was ready; the tables were set, the drink stand was open for business (first drink free), the spaghetti was cooked to perfection and people were beginning to line up in anticipation. Fresh garlic and onions had been chopped, bread had been cooked, and the salad prepared. Let's eat!! The buzz in the room grew, as everyone settled in to enjoy their meal, with attendees talking and laughing with each other, confirming the A.A. adage that we are not a glum lot.

After dinner, as everyone enjoyed the potluck desserts, an esteemed panel made up of experienced Teleservice members, assembled on stage to answer questions submitted in an Ask-it-Basket. The questions ranged from

"Can I use my cell phone for online shifts?" to "What if I can't find someone to go with me on a Twelfth Step Call?" The panel's wisdom, coupled with their sense of humor, made the question and answer portion of the evening extremely enjoyable and informative.

At 8:00 the AA meeting began. The speaker, Joe *G.*, has been a volunteer in Marin Teleservice since its inception. In fact we learned that the first shift ever in Marin was his on a Friday night in June 1989. He spoke eloquently on his personal history of drinking and recovery and touched on the importance Teleservice has played in his sobriety. The meeting wrapped up at 9:00 and by 10:30 the tables and chairs had been put away, the pots washed and the floor mopped. Another successful Spaghetti Feed was in the books.

Historically the Spaghetti Feed served as a Fund Raiser as there was considerable concern as to whether or not Marin Teleservice could meet all its bills. Today Teleservice is fully self-supporting and now the annual event's main goals (other than not losing money) are to keep Teleservice in the forefront of peoples minds throughout the year, and to recruit new volunteers which ensures that when a suffering alcoholic calls, the phones will be answered 24 hours-a-day, seven days-a-week by a recovered alcoholic. Although the term fundraiser is no longer used, the event still raises funds, which allows Teleservice to make a considerable contribution to Central Office.

Trouble was, I was afraid of losing the things I had. Everything seemed out of my control and I felt like a fraud. I listened to the people with more sober time, and all I heard was that everything was good.

I met a fellow who shares my sobriety anniversary. He was at the time coming up on his first anniversary, and after I shared about how afraid and alone I felt, he reached out and introduced himself after the meeting. Right then, I realized that once again, the April Fools' joke was on me. Listening to people with more time than myself may have been good for me as a newcomer, but with a couple years behind me, I couldn't afford to tune out people with less time sober. Things were not what I thought they were.

As I continued to go to meetings, I noticed what I'd been missing. People sober for six months, 90 days, even 30 or fewer days—were sharing about what they were doing to stay sober and live life on life's terms that day. In their sharing there was never any of what my sponsor calls

"alcoholwasm," where it's all about how good things are today and how all the problems are in the past once sobriety rolls around. I don't know about anyone else, but I need to hear what tools other people are using today to keep living life without escaping into a bottle.

Don't get me wrong. I still get a lot from old-timers sharing, but I think I finally started to understand what the old-timers mean by "the newcomer is the most important person in the room." Things are not what I thought they were.

This has become a recurring theme for me, and as I approach my sobriety anniversary, I try to remain open to the April Fool pranks that my Higher Power sets up for me. When I remain humble and relaxed I can find out that things are not what I thought they were and laugh and learn from them. When I try to hang on to my old ideas - even ideas that have served me in recovery - I make myself the butt of the April Fool pranks.

Dear Alky,

I've been sober for just over four years now. I recently completed steps 4 through 8 with my sponsor, and I'm beginning to make amends (step 9). The problem was that the first person didn't seem to trust my

motives about making amends, feeling like I was only doing it because I "had" to. How do I deal with making amends to fellow members of AA?

I can understand the feeling this AA member had and I don't think that feeling is unique to recovering alcoholics. Those outside of the program can mistrust our motives as well for the very reason you mentioned.

There's no way out of the need to make amends, but there is a lot of room for creativity in how we deliver them. I have found it very helpful to speak to all people in simple, everyday when I make amends. So, instead of saying "I need to make amends to you for this...." I say "I'm really sorry I said that to you the other already knew that." It's Dear Sober Grrrrrl, day" or "I was wrong to assume that you a subtle difference but I think a significant one. AA jargon can really be a turn-off during an intimate conversation. Using everyday Good point. I agree that the suggestion you mentioned works language shows that we are communicating as equals - fellow hu- well for the straight population and perhaps not-so-well for the man beings - and not "making amends" in some clinical "AA way."



Sweating it out in the Mission

Dear Sweating,

You are right to identify this as a potentially slippery slope. Over the years I have heard several members state that they relapsed over Alky 🚹 painkillers that were prescribed by well-meaning doctors and, at first, taken as prescribed. The problem in each case was that the alcoholic, at some point, began to over-medicate - he no longer followed the doctor's directions.

I have also seen examples in meetings of individuals, like you, who were very concerned and took precautions. They spoke about it at the group level. They frequently spoke with their friends and sponsors about taking the medication (and their feelings about taking



Some health problems and issues post-surgery can be incredibly painful and you may very well need a narcotic painkiller. Only your doctor can decide this. If you

practice HOW (honesty, open-mindedness and willingness) during this time, you should come out of it sober, wiser, and able to pass on your ESH (experience, strength and hope) to others in similar circumstances.

The general rule, as far as I can see it, is to find a sponsor where there will be minimal entanglements, complications and blurred boundaries. It's hard enough working with a sponsor when the relationship is simple, why complicate it unnecessari-

If an AA member is feeling attracted to her sponsor, I would suggest that she speak with a trusted friend about it. She may find she needs to bring up the issue directly with the sponsor. The crush may diminish if aired and boundaries can be re-set, or if reciprocated, the lovebirds can become a new couple and the sponsee can go find a new sponsor.

Stay in the Middle of the Lifeboat

After I had been sober for a few months, my sponsor "suggested" that I get a commitment. I had only months before returned to Alcoholics Anonymous from a six-month relapse after being sober for over fourteen years. I was a mess. The fear of people and the shame of relapse had a death grip on me, but I promised my sponsor that I would be willing to go to any length to stay sober.

After a couple of weeks he asked me to what meeting I had committed myself to service. My lame response was that there were not any commitments available in the meetings I had been attending. "Everybody raised their hands before I could raise mine." Truthfully, I was scared to raise my hand in a meeting. Drawing any attention to myself chilled me to the core. He did not understand how just picking up a chip was an experience in terror. Sheer mortifying terror. I felt I had presented my case flawlessly, and he would drop the issue. What could he reasonably say? I had tried

Then he reasonably asked, "Did you ask the people who volunteered if there was anything you could do to help them?"

I froze. "But I always help picking up coffee cups and putting away chairs."

Good, he said, but not good enough. Why do I have to get a service commitment, anyway? They will laugh at me for thinking I am good enough for a commitment. I will make a mistake and that will confirm my stupidity.

So, I figured that I would start small. I would raise my hand

when the secretary asked for volunteer to bring the sweets. Then I will probably have to say my name because nobody knows me. Gosh, I hate this. I did it and sure enough I had to say my name aloud. I wanted to disappear.

So the next Tuesday night came and it was time for me to be the sweetie. I got off work at six-thirty that evening in Noe Valley, caught the unpredictable 49 bus to my house in Potrero Hill, changed from my suit and tie, ran down the hill to catch the 22 Fillmore to Fell Street so I could run down that hill to Divisadero for the meeting at eight. I did not know that I needed to be there a little earlier than usual.

I got off the bus at Fillmore and Fell at seven-forty in a panic. I ran down to Divisadero. I hadn't bought any cookies because I was in such a rush from work. (Never mind I could have bought them on my lunch hour.) I went to a gas station and spent thirty dollars on Hostess Twinkies, Ho Ho's and Sno Balls. My mouth was dry and I was sweating all over. I hurried into the meeting space at five to eight. There were already cookies there. Someone had gone to get them because they didn't think I was coming. Oh, God. I screwed up bad. How could I...? These guys hate me. I am the worst. I'll never get it right. As soon as the meeting was over, I left the meeting. I was so embarrassed, I went to a different meeting for the next three weeks, and it took me several months to let go of it.

My sponsor laughed when I told him how horrible I thought I was, and he continued providing unconditionally loving

Literature Review: As Bill Sees It

Sobriety sucked, and two months of intense group therapy at Kaiser's chemical dependency recovery program left me hungering for another way to address my lifelong fear of people, places and things. So long as it was not a way that I had concocted - after all - my way did not work.

My new way out became AA, the experience, strength and hope of a wonderful sponsor, and a vast fellowship of AA members primarily based in my home group. This group was based on readings contained in the book "As Bill Sees It."

The first hurdle, or rather, my fear that Bill's pithy plain speak helped me jump, was the acknowledgement of acceptance of a power greater than myself. Since I could not see, touch, or smell, let alone feel, I had always rejected faith in a God. In "As Bill Sees It" on page 225, The Answer in the Mirror helped me, along with listening to members, shares, to feel at home in that room, really for the first time in my

life. The Coming of Faith on page 51 also helped let me identify with all the other members to one degree or another, being brought to my knees, a great leveling device, a common experience defying all social and economic strata. I was and am not unique and different.

Page 31, In God's Economy, taught me to be forgiving of my-self for my past failures in attempting to achieve sobriety. In other words, to lighten up! In forgiving myself, it occurred to me that I could and should forgo blaming others and my-self for all my problems, live and let live, warts and all if you will. After all it was not up to me to judge. I believe we all do the best we can - even if it or that effort does not measure up to "my standards." I no longer feel alone and afraid. In short, I guess I have joined the human race and am now capable of loving and being loved.



We will comprehend the word serenity and we will know peace By Peter W.

When I was an active drinker, I had no comprehension of serenity or peacefulness. What I experienced through alcohol was either euphoria—getting high and losing my inhibitions; or anesthesia—calming my frazzled nerves and deadening my senses. It never occurred to me that I could relax and be quiet without a drink, much less make decisions or take action. When I confronted troubles in my life (fear, anger, hostility, or envy related

to family, money, job issues, and relationships), my strategy was to "think my problems through" with a glass of Scotch in hand, not realizing that the biggest problem was the stuff in the glass! Needless to say, I rarely solved anything, and many problems grew worse over time. When I sobered up, it was a challenge to learn the new strategy found in the seemingly simple language of the Serenity Prayer: accepting what I cannot change, changing what I can, knowing the difference between the two.

The authors of the Big Book were careful to specify in this promise that we will comprehend the word serenity, not live in a constant state of serenity; that we will experience peace, not that we will always be peaceful. In my practice of the program, serenity and peacefulness are standards against which I can measure my emotional state at any given time. Since I now have some experience of serenity and peace, I will sometimes sit back and realize how far from these ideals my current condition is. It can be startling, even frightening, to see how far I can regress into emotional responses that I'm supposed to have given up long ago. When I'm in a particularly black mood, it's tempting even to think that the promise of peace and serenity is a hoax.

I'm going through a career transition as I write this. I recently retired from a company where I was employed in a really good job that paid well and was generally very satisfying. Since I still need to work, I find myself in the job market for the first time in almost 20 years. The economic picture is not very good, and there have not been a lot of new prospects. So I send out resumes, and nobody responds. I talk to my network of contacts, and there are no leads. And what's my reaction? Fear, anger, hostility, envy. I get depressed and very difficult to live with (just ask my partner!). Sometimes I don't feel very much like a person who has been sober for more than 25 years. But at least to-

THE FOURTH PROMISE day I don't try to solve my problems with a glass of Scotch. Instead, I say the serenity prayer. In other words, I ask for help, however grudgingly. Then I move to Step II and do some inventory to try to find out what can be changed and what cannot. Finally, I start taking action that will lead me back to the path of serenity and peace. I may not be very enthusiastic about any of this at first, but it always helps to get back in motion, and soon I real-

ize that the alternatives (doing nothing, stewing in my discomfort) are not acceptable today.

In promising that we will comprehend the word serenity and we will know peace, the authors of the Big Book were not offering us a rose garden. Remember that the promises begin with the caveat "If we are painstaking about this phase of our development" (that is, clearing up the wreckage of our past) and they conclude with another qualification: "They will always materialize if we work for them." This means that we have to take action if we expect results.

In frustrating situations like my current job hunting, taking action usually means revisiting some AA basics. I have to remember that none of us is perfect, but that we have tools in the program to correct a situation that begins to get out of hand. You know the tools—they are the same ones I started with. They work just as well for me today as they ever did:

- -Call my sponsor.
- -Go to a meeting.
- -Work the steps.
- -Talk to a newcomer.
- -Get a service commitment.
- -Prav

Will these actions get me a new job? No, but they will help me stay serene in the face of a job market that I cannot change. They will remind me that I can do the footwork to explore new alternatives and be open to all the possibilities. Above all, they will show me peace and serenity in the fact that I'm not alone in this or in any part of a sober life.

support as I, eaten up with self-hatred, continued my search for a service commitment. I had to get one because I now knew how self-centered fear actually had the power to remove me from the fellowship of Alcoholics Anonymous. I had seen that by my fear of returning to that Tuesday night meeting.

A few weeks after the sweetie experience, I volunteered to be the breakdown person at my Wednesday meeting. *Cool, I* won't have to talk to anyone. I can do this.

Almost immediately I would experience what it means to be a member of an A.A. group. I was learning to talk to people again. My confidence was growing as I contributed responsibly to the group. I was so glad to be home again-to feel the brotherhood that I had known, loved and needed during my fourteen years in the program before my relapse. I had a long way to go. The relapse had damaged me and my life considerably. But now, through service to Alcoholics Anonymous, I was back "in the middle of the life-boat."



How It Works in NYC

I had the pleasure of visiting AA's General Service Office (GSO) in New York City in February. I also had the privilege of meeting the GSO Staff, the employees who fill the ten rotating positions that must be filled by AA members. This was one of the biggest surprises – GSO is mostly staffed by non-alcoholics! Out of 83 GSO employees, 10 are alcoholics and 73 are non-alcoholics.

The ten AA members on the rotating Staff are manager-level and work the various service "desks" including Public Information, Cooperation with the Professional Community, Regional Forums and Conventions, and Corrections. GSO takes the "spirit of rotation" seriously - these ten employees rotate into new desk positions every two years. The General Manager position is also a two-year rotation, currently held by Greg M., a past trustee from the Pacific Region. AA's founders strongly believed that if individuals rotated frequently there would be less risk of being seduced by power, prestige or money. Salaries and benefits are all conference-approved and there are no deviations from that schedule. (The next rotation is scheduled for July of this year.)

Many of GSO's activities revolve around the yearly conference which is

attended by delegates from the US and Canada, as well as trustees and GSO staff. All of the business that concerns AA as a whole is discussed at the conference, which takes place each April in New York City. The rest of the time the GSO staff is very much a "correspondence" office that answers our letters, phone calls and emails. GSO has a ten-day turnaround policy on all correspondence.

I spoke with Staff who have stayed the night through to answer our questions, who often take work home at night, and who put in many hours above and beyond the call of duty as their labor of love to AA. They travel about once a month to various conferences around the US and Canada and are frequently called on to speak, either telling their personal recovery stories or informing a group on the latest developments at GSO.

If you are ever in New York City, it is worth taking time to visit this AA "Mecca." The office is located at 475 Riverside Drive at 119th Street in Morningside Heights, just north of the wonderful and bustling Upper West Side. Fridays are a good time to go – there is an AA meeting that takes place at GSO in the conference room at 11 AM and you are welcome to attend and meet the GSO staff for yourself.
