So, You're Going To Lead A Meeting?

In celebration of Founder's Month (June 10, 1935 marks the beginning of A.A.) our lead article is a wonderful piece courtesy of the Friday Forum Luncheon Club, a noon meeting at the Mayflower Hotel which met every Friday in Akron, Ohio (A.A.'s birthplace) in the 1940s. The following is from a leaflet that was prepared by group members interested in sharing their experience with those whose turn it was to speak before an A.A. meeting for the very first time.

In the "Foreward" it is stated that it was assembled by "a score of A.A.s, mostly veterans of a year or more..." How times have changed! I'm not sure anyone with less than 20 years sober in A.A. is considered a veteran these days... But, remember, this was written in the 1940s when our fellowship was still new.

It is interesting to note, that as with the Big Book, so much still holds true for alcoholics today. The advice is timely, it is still fresh and it will surely resonate with anyone who has had to endure an interminable drunkalogue. The advice is valuable for seasoned speakers as well. And yet, as with everything in A.A., these are suggestions only. The "Foreward" says this is not Gospel, nor meant to be definitive. As a suggestion, one can try it for results and see if it works. If not, throw it out.





mean sit down and write out a speech. But organize your subject matter beforehand. If you have any doubts as to your memory – and remember, you may experience stage fright–prepare written notes. After preparing them, follow them closely or you may get off on a tangent, find yourself in a thicket of verbiage, and have difficulty in finding your way back into your notes. Remember, you owe your audience some consideration. To speak before a group with no preparation is an insult to their intelligence.

Be Brief. There is a saying among modern clergymen: "No souls are saved after the first twenty minutes." The two-hour, yes, even the one-hour sermon is a thing of the past. In almost all cases effectiveness is lost after thirty minutes.

After the first half hour the average listener starts to wonder when the speaker will come to a climax and stop talking. His mind wanders, and what good the leader has done in his first half an hour immediately becomes undone. The longer he continues to talk, the less his listener will remember when it is all over.

Remember, alcoholics are restless people. They squirmed at sermons, twitched at movies, avoided long plays and concerts, almost never attended lectures. Demosthenes himself could not hold an alcoholic audience for more than half an hour. Don't flatter yourself by thinking you can. If you don't own a watch, borrow one and keep an eagle eye on it. When your half hour is running out, come to a speedy conclusion. Your audience will be profoundly grateful.

Be Brief. Lincoln's Gettysburg address lasted four minutes. The principle speaker of the day, Edward Everett, talked for two hours. No one but a professional historian today knows what Everett said. Every school child can give Lincoln's talk verbatim.

Be Brief. Speak up. Don't Mumble. Trained orators in the days before public address systems developed a hard and fast rule: Talk to someone – a friend if possible – in the very back row of the auditorium. Then you will be sure every one in the hall will hear you. And take your time. If you speak deliberately you may not crowd as many words into thirty minutes, but at least they will be understood.

Be Brief. Your audience knows you are an alcoholic and

a member of Alcoholics Anonymous. Your presence on the platform is proof of that – except in a few rare occasions where the speaker may be a non-alcoholic, and will be introduced as such. Consequently it is ridiculous to "qualify" yourself. It may be necessary to give some of your drinking history to illustrate what obstacles you had to overcome to become a practicing A.A. But keep it to a bare minimum. Avoid as you would the plague a blow-by-blow account of your drinking days and experiences. There are probably a dozen persons or more in the audience who can give you cards and spades on drinking background.

A recitation of drinking experiences has a definite place in the A.A. program. It establishes a bond between the A.A. and the man who may some day be a member. It helps convince the new man that he is not the only one in the world who has a problem. So your drinking story is valuable when you call on the prospect in his home, in jail, or in a hospital.

But at a meeting the audience is more interested in WHAT YOU HAVE DONE TO KEEP SOBER. Draw on your drinking experiences to illustrate points and make an end of it. "HOW I KEEP SOBER" should be the topic of EVERY A.A. leader.

Be Brief. Following are a few brief suggestions: Don't try to cover everything you know in one talk. You probably will be invited to lead at some future date. Try to use as much new material as possible in each talk. The man who heard you Monday night might hear you again on Thursday. No one knows all the answers. Don't give the impression that you are an exception to this rule. Don't read lengthy poems or quotations of any kind. They are boring. If you must quote, be brief. Don't criticize. Leave that for your fifth anniversary. And when your fifth anniversary comes, don't criticize. Be sincere. Don't be dramatic or play to the grandstand. Don't get involved in circuitous analogies. Someone has already built the ladder or constructed the house probably better than you can. Don't be too positive. Rather, have strong suspicions.

Many a man who "is never going to take another drink" on Tuesday night is plastered as a new house Wednesday morning. Don't feel you must have a weighty answer to every comment from the floor. If you have no simple comment, a "thank you" will handle the situation. When you are finished, SIT DOWN.

Dear Alky,

I missed seeing your column in the April point. I always get a lot out of the questions and answers. Many of the questions are thoughts I've had in my own mind. Of course I've never written to you. I left that to others. I see now that I did the same thing with my meetings. I'd go and just expect the meeting to be there. I didn't volunteer or even raise my hand to share. I guess I figured someone else would bring up what was on my mind! Then I wouldn't have to put myself "out there". After reading your April Column (so to speak) I thought "what if I go to my meetings and they're not there?" Then it will be my turn to ask "Is everyone

recovered?" I have now made commitments at two of my meetings. One as a co-coffee maker and the other setting up chairs. I still haven't raised my hand to share, but I'm working up to it. I'm trying to be more responsible for my own sobriety.

Dear Speechless,

I make perfect sense out of what you shared. I would never have known that you had any difficulty in expressing yourself. I felt like you when I was a newcomer and I still feel that way sometimes today. We share <u>our</u> experience, strength, and hope with each other. We gain, willingness, courage, and faith from each other's shares. If we went to meetings where newcomers and old timers didn't share we would be celebrating fewer AA Birthday's. A large part of the success of the AA program is the fact that we are willing to share with one another. Everyone has something to say that someone in the rooms can identify with. By

sharing we help others and we help ourselves. In chapter 7 "Working With Others" it says "Practical experience shows that nothing will so much insure immunity from drinking as intensive work with other alcoholics. It works when other activities fail. This is our 12th suggestion, carry this message to other alcoholics! You can help when no one else can." (Big Book, Pg. 89)

Dear Point—

I've been an avid reader of *The Point* for a few years now and am grateful for such a fine publication. This gratitude got me thinking about A.A.'s founders and how grateful I am to Bill and Bob. I knew that June was coming up and our Fellowship was founded on June 10, 1935 (in my home

state of Ohio, no less!). From what I've read about this, Bill was the first of our Founders to hear some of the message through the Oxford Group, a kind of evangelical society, but I won't hold that against him. You get it where you get it. But, the difference with Bill was that he couldn't help but feeling that he could save himself from the obsession of alcohol by helping another in the same situation - alcoholics helping alcoholics.

It was no coincidence that Bill met Bob in that June of 1935 in Ohio. I guess Dr. Bob was having the same troubles with the bottle and was persuaded by his family to talk to Bill. Well, apparently that idea of one alcoholic helping another came to fruition that June afternoon and the Fellowship of A.A. as I know it, was born.

Now, 71 years have passed since that first meeting and it still goes on today. I know things have been translated and adapted somewhat to the changing times and attitudes about what makes an alcoholic and addict these days (wasn't Bill put on barbiturates at one time as a supposed "alcoholic cure"?), but the basic message is the same. I look at Tradition Three and realize that the whole thing is pretty simple. Not easy, but simple. Of course, there are those in "modern A.A." who like to quote Bill W. and feel the need to interpret what his true messages were as if they are channeling him, but that really doesn't matter. We all have what we need in the Big Book and the 12 and 12 (NOT the 12 BY 12!) and are free to read and interpret what we read in our own way. Bill and Bob simply shared their experiences with others still suffering back then and the same dialog happens today. Bill even declined the chance to have a statue or plaque in his honor as a Founder of A.A. That's a pretty good example of humility in my book.

So, at this time of Founders' Day, I just wanted to say, "Thank You" again for continuing to carry the message to all of us alcoholics out there and keeping alive the words and wisdom of those first two guys who met in Ohio.

Big Book Study: Chapter Five—How It Works

I remember reading Chapter Five of the Big Book for the first time. I was in the doughnut shop at 25th Street and Church Street, hovering over my book so no one could see what I was reading (as if anyone cared, or noticed).

I furtively underlined the lines describing the metaphor of the actor running his life on self-will. The actor who "wanted to run the whole show; was forever trying to arrange the lights, the ballet, the scenery and the rest of the players in his own way." I was jarred by the similarities of my own experiences and the text. I too naively believed that if my arrangements would stay put, and if people would do as I wished, my show would be great.

While in college, I fell madly in love with a boy. As described in Chapter Five, I did everything I could to get us

and keep us together, and ensure that my "show" was a success. I was kind, considerate, patient, generous; even modest and self-sacrificing. At others times I was, mean, egotistical, selfish, manipulative and dishonest.

By the end of my senior year, the boy I had scripted to play, 'love of my life' was secretly dating my best friend. I found out after snooping through her cell phone and finding text messages he sent to her. I remember thinking that my melodramatic life was similar to the soap opera, *Days of Our Lives*. The only differences of course, were my mutinous cast members.

A year and many "unscripted" disappointments later, I started to realize that no matter how hard I tried, how much I planned, how many lies I told, or how manipulative I was, I could not orchestrate the outcomes of my life. I wholly identified with the angry, indignant, self-pitying director, even felt sorry for him. My life mirrored his exactly; self-will run riot. How had I gotten there?

I grew up in an alcoholic home marked by anger, chaos, and confusion. Being the eldest of two daughters, I believed it was my duty to claw my way out of the hole we were in, carrying my family in tow. I had no faith that my parents or even God could take care of me. I was obsessed with planning and calculating to ensure I got what I needed. I saw myself as a soldier fighting the

battle of life.

I was in essence, a ticking time-bomb ripe for self-destruction. At the root of my obsessive planning was a basic fear from which all others spawned; a fear that I wouldn't be taken care of. When I was first sober, I was ignorant of how these fears manifested in my thoughts and actions; I only focused on the wreckage the fear caused. By doing Steps Three and Four with my

sponsor as outlined in this chapter I saw how fear ruled my life.

I took Step Three and turned my will and life over to a power greater than myself. The Third Step in action meant letting go of my conniving and manipulative ways, also known as "fixing situations." My sponsor read the passage in Chapter Five describing God as my new Employer. "Being all powerful, He provided what we needed, if we kept close to

Him and performed His work well." She reminded me that my new Employer did not need my help "fixing things."

The second example of my Third Step in action was working my Fourth Step. I commenced to put pen to paper and saw the insanity of my thoughts. I saw that my fear had many guises and manifested itself in a multitude of ways. I saw that I was self-seeking because I was afraid I didn't have enough. I was ego-centric because I was insecure. I lied because I thought the truth wasn't good enough. After completing the steps, my fear slowly receded and my faith in a Higher Power increased.

Several weeks ago, a friend posed an interesting question; what if I acted as if everything was just as it should be? What if I believed God had taken care of it all? What would life be like? A passage in Chapter Five describes the results of such a situation perfectly,

"As we felt new power flow in, as we enjoyed peace of mind, as we discovered we could face life successfully, as we became conscious of His presence, we began to lose our fear of today, tomorrow or the hereafter. We were reborn." (p. 63)

Having faith that God has taken care of everything allows me the freedom, joy and happiness to just enjoy the show.

Graduation from AA?

Do we ever really graduate from A.A.? I am ever so grateful that the answer is a resounding and definite "No." But we do have milestones and commencements—new beginnings.

A big milestone in A.A. was taking the First Step, which took me a very long time because I was a periodic drinker. I could go as long as several years between drinks. When I did drink, though, it was always to a quick blackout.

I had such a hard time with Step One that I didn't raise my hand to celebrate my first birthday. Now, at twelve years, I proudly raised my hand and walked to the front of the room to collect my chip.

Every time there is an ending in my life, I feel intense grief and then realize that a new beginning is just around the corner. Perhaps this is why graduations ceremonies are called commencement ceremonies; new beginnings.

When each of my children left home to go to college, I felt intense grief for the end of the relationship as I had known it. The teenage years were spent with me learning to move from manager to consultant in each child's life. The new beginning was learning to have an adult relationship with each child as they learned to find their way in the world. Their way, not my way. God's will, not mine. I am surprised to find that I enjoy an adult relationship with each child even more than the day-to-day care giving.

My life became very full as I got sober AND worked a program. Working the A.A. program has given me the tools to not only accept life on life's terms but to thrive! I am now working the steps again with a new sponsor. We just finished some very intense Fourth and Fifth Step work. Working the steps is work, but the healing is unbelievable.

In fact, the more recovery I have, the richer and fuller my life is and the more tools I need. The tools come in the form of more meetings, more step work, more sponsoring, and more reaching out. I know that if I skimp on the recovery process, my recovery suffers. I believe that life offers us so many gifts and I want to be in a space to receive them and be grateful for them.

I remember hearing a woman at a meeting years ago say, "When things don't work out as I expect, I get really excited because I know that God has something special in store for me." I'm not quite at that level of recovery, but *I can* practice acceptance when things don't work out as expected. When I am able to get excited about unplanned and unexpected experiences, I will be at another milestone. This will be a graduation or commencement to a new level of recovery, and I will need my bag of A.A. tools more than ever!



Literature Review I Am Responsible: The Hand of AA

"I am responsible. When anyone, anywhere reaches out for help, I want the hand of A.A. always to be there. And for that, I am responsible."

This simple declaration was presented to the fellowship at the 30th International Convention in Toronto, Canada in 1965, and captures the heart and soul of fellowship - one alcoholic sharing with another, one hand reaching out for the next.

This is also the title of a new book published by the A.A. Grapevine. It consists of 38 stories written by A.A. members and non- alcoholic friends of the fellowship, and explores taking responsibility for ourselves and others. There is a brief introduction by Bill W. written at A.A.'s 25 year point called "The Shape of Things to Come", where he wonders about the next great phase of A.A.'s life.

The stories are divided into seven sections which cover everything from carrying the message, to working with others. The stories are short and simply written, but their power and importance are immeasurable.

One such story is "A State of Honor," published in 1967 and concerns a tiny, very old Indian woman named Mary, who arrives at a meeting, takes a chair at the back of the room, and never looks at anyone during the meeting. Afterwards, she quietly approaches the author of the story, who is putting away the chairs. She asks for help because she can't stop drinking and explains that her old-fashioned son had forbidden her to ask for help. It was a common conception that the Indian people could take care of their own and great shame was associated with going outside the family for help. She had sneaked away from home to seek help.

For the next hour they talked and the author gave Mary an emergency supply of A.A. literature, a big book and a copy of the serenity prayer. Six months later she returned, sober, to thank the author for saving an old woman's life. I won't give away the ending but it brought me to tears.

I Am Responsible is a wonderful addition to the A.A. library and a great read for newcomers and oldtimers alike.

Intercounty Fellowship Annual Meeting

The Intercounty Fellowship Board (IFB) is the Board of Directors for the Central Office Serving San Francisco and Marin.

What is a Central Office?

"A central office (or intergroup) is an A.A. service office that involves partnership among groups in a community—just as A.A. groups themselves are partnerships of individuals. A central office is established to carry out certain functions common to all the groups functions which are best handled by a centralized office—and it is usually maintained, supervised, and supported by these groups in their general interest. It exists to aid the groups in their common purpose of carrying the A.A. message to the alcoholic who still suffers.

"Service centers usually have no authority on their own account; they derive it from the participating groups. Local group representatives reflect the groups' conscience in the service center operations.

A Day for my Father

The relationship with my father was always a little rocky. He was a devout Mormon and right wing activist. I was a charter member of the flower power generation—a hippie. As a father, he did his best to tell me the dangers of drink and drugs. He sought to instill in me, a love for the Mormon Church, the Vietnam War and segregation. I wish I could say it was some superior morals that repelled me from his values. But it was far-more simple: While living under his roof—I couldn't party the way I had to.

I moved out at 17 and never looked back, rarely contacting him, and then only to borrow money or a car. My mother died when I was 26 and he quickly remarried. His new wife didn't regard me as the prodigal son—she'd scarcely talk to me. When she would answer the phone, I could hear her yell to my dad "*that boy* is on the phone" But each time my father got on the line, his voice was always the same: loving and excited to hear from me—consistently offering encouragement and love.

That went on for 20 years—I didn't get sober till I was 47. All I could muster for my initial amends was a simple postcard that read "Dad I'm sober and doing OK". But at three years of sobriety, I was ready to approach him, to speak to what a bad son I had been.

I wrote out a letter to him, not to be mailed—or read aloud, but for my sponsor and I to make sure I was on the A.A. beam. My sponsor looked over the letter and said "loving words, and I imagine that they will sound great in the telling. But are you willing or even capable of living up to them?"

I called my dad the next day and asked if I could fly down for a visit. He said 'of course, but what on earth for?" I only said that 'Perhaps I can start being a better son in your life".

When I got off the plane, he was standing at the gate—crying. Then we were both crying. We held each other as we had when I was five years old. That night I spent an hour alone with him making amends. After he went to bed, his wife came into the living room. I had vowed that I wouldn't make amends to her.......But I did.

I flew back home a different man.

My father died one year later. He died an honorable, painless death. We spoke on the phone nearly every day before he slipped away—laughing and reminiscing. He passed away with the firm knowledge that we both loved each other. I participated in his funeral, head held high, without debilitating shame.

Now I am a father, I have three grown daughters. Hopefully I can apply his gift of unconditional love to them.

Young People in AA: ACYPAA

When I was a kid, I'd ask my mom, "how old are you?" and her answer was always "21+." Now that I'm 48 years old and mom is still "21+," I understand the issues of growing older a little better. In Alcoholics Anonymous, we hear young people's groups describe themselves as those with "room to grow," because that seems to include all of us! Clearly having room to grow, I accepted the invitation to attend the All California Young People in Alcoholics Anonymous (ACYPAA) convention held this year, February 23rd - 26th in Santa Clara and organized by PENYPAA, the Peninsula Young People's Group in San Mateo County.

While it took me a while to get used to some of the chanting (ACY!! ACY!! ACY!! PAA!! PAA!! PAA!! which was appropriate for ANY situation at the convention) and some of the activities, which included mini-bicycle races, a drag show, a comedy show, dances and karaoke, I quickly recognized the similarities to the A.A. program that has enabled me to stay sober for over 10 years. The panels (including a long-timers panel and discussions of service opportunities and A.A. history), marathon meetings and, particularly, the main speaker meetings were inspirational. The Saturday evening meeting included a County Countdown which reflected attendance from all over California, including A.A. members from San Francisco and Marin, and beyond our borders with members from Arizona, New York and Texas present. It was great to see San Francisco/ Marin

participation with Philo H. sharing at the closing meeting on Sunday morning.

In the end, ACYPAA was about carrying the message of Alcoholics Anonymous to the alcoholic who still suffers and that's the program I am familiar with. There were over 2,000 alcoholics, young and not that young, that attended the weekend in Santa Clara and my experience was a very successful one. The theme of the convention, "The effect was electric," comes from page 14 of the book, Alcoholics Anonymous, and refers to Bill W. describing his own spiritual awakening. The energy and enthusiasm of this gathering of sober alcoholics at ACYPAA clearly created an "electric" atmosphere that won't soon be forgotten by those that attended. The event was well-organized and extremely welcoming and despite my initial hesitation, I left ACYPAA reminded of the power of A.A. unity and grateful that A.A. is open to all regardless of their age.

Following is an unofficial summary of actions, information, upcoming business and service opportunities discussed at the May 2006 IFB meeting. 1. IFB Reports

Chair's Report: Steve R. gave the report. Next month is our Annual Meeting at 7pm followed by our regular meeting at 8pm. Reports from the events of the year past are given. Nominees to the COC are to be called for. Tonight the second reading of the Bylaws change will take place. The issue of free events will be discussed. The flyer and pamphlet policy will be re-considered.

Central Office Manager's Report: Maury P. gave the report. Next month is the Annual Meeting. Anyone submitting a report needs to email it to Maury by 5:00pm Monday, June 5th. Please distribute Annual Meeting flyers to the meetings you attend. Phone volunteers are needed to cover for summer. The May 2006 schedules will be available May 17^{th.} Central Office is closed Monday, May 29th for Memorial Day. The 56th Annual General Service Conference is over. Francisco A., our Delegate, will report at the Post-Conference Assembly on May 20th on

the news of the proposed Central Office pamphlet. The new flyer policy that charges \$.05 cents for every copy made at Central Office does not include IFB committees.

Central Office Committee Report: Lauren H. gave the report. An upgrade to the Central Office network firewall was approved. The pamphlet 'Welcome to the IFB' will be updated. Flyers for events at the Alano Club may be included in *The Point* as long as they follow the existing Point Flyer Guidelines and are not promoting fundraising for the club itself. Meetings listed in *The Point* calendar should be held regardless of whether all members can attend. The Central Office Manager was given a pay increase after her performance review.

Treasurer's Monthly Report: Danna P. gave the report. The net loss for March was (\$3,228), which is \$887 greater than the budgeted net loss of (\$2,341). Unrestricted cash as of March 31, 2006 totaled \$49,303 and is sufficient to pay the budgeted expenses for three months. Unrestricted cash decreased by (\$2,032) since February 28th primarily due to the net loss for March, offset by a \$485 increase in Account Payable. Prepaid Expenses increased by \$478 due to prepaying a Grapevine order. Deposits decreased by \$1,210 which equals the \$840 refund received plus a penalty and premium adjustment.



2. Bylaws Reading

Steve R. read Article V, Section 10 of the Bylaws and added the proposed sentence at the end that read, "Former reps returning for a new term after an absence of more than two years are required to attend orientation."

3. Group Rep Reports

Steve R. of Valencia Smokefree reported that his group requested that Founders Day and Unity Day be free events.

4. Special Events Committee

Free Events Discussion: Because of the success of the Anonymous Prom and the income it provided Central Office, should certain events be free.

Motion: Based on our current financial strength and the great revenue generated at the Prom, that we give the fellowship Founders Day.

A.A. Acronym—F.I.N.E.

Who makes these things up and how do they become part of our folklore in A.A.?

I understand that word of mouth recovery has to be brief and easily coded. That way the principles and values we hold can be easily remembered. Slogans, short quotes, even a page number (449) can speak volumes.

The acronyms that become common in our A.A. vocabulary attempt to convey the principles and values we live by.

The most frequently used acronyms in A.A. are HOPE, FEAR, SLIP and "ISM", one of my favorites.

There is another acronym that is not as commonly heard, and my least favorite because it implies the user is making a snap judgment and shuts down any honest communication. Or insinuates the person who says he is "fine" is shallow and unaware of deeper problems.

"How are you doing?"

"Fine, Thank you."

"Oh, You mean you are really f***ed up, insecure, neurotic and ego-centered?"

I usually turn and run as fast as I can from these A.A. spot-check inventory takers, who demand that every casual interaction result in hours of prolonged expression of deeply held fears, secrets and inferiority.

Usually if I reply with "Fine" there is a good indication I have very little to disclose to the person making the inquiry. Any further attempts to solicit information from me may result in a later need for an amends.

While the acronym may be a helpful tool in my daily Tenth Step personal inventory, I bristle if every greeting, before or after a meeting, is turned into a gestalt session.

Def. Gestalt psychology: the study of perception and behavior from the standpoint of an individual's response to configurationally wholes with stress on the uniformity of psychological and physiological events and rejection of analysis into discrete events of stimulus, percept, and response.

The Acronym Finder allows users to decipher acronyms from a database of over 430,000 entries. For some of you, this can be very entertaining activity between meetings.

These are the entries for the word FINE. As in, "How are you doing?" "Fine!"

FINE: Feeling Inadequate, Needing Encouragement

FINE: Feelings Inside Not Expressed

FINE: Fickle Insecure Neurotic and Emotional

FINE: Foggy Insecure Neurotic Emotional

FINE: Fouled Up, Insecure, Neurotic and Emotional (polite form)

FINE: Freaked Out Insecure Neurotic and Emotional

FINE: Frustrated Insecure Neurotic Emotional

I, for one, am learning to accept myself as a Foggy Insecure Neurotic and Emotional individual. If I tell you I am fine, please leave me alone. If I want to do a Fifth Step, I'll ask my sponsor.
