t's a truism in San Francisco and ▲ Marin that tenants have a harder time finding affordable space than landlords have finding tenants for their vacancies. This is true for residential as well as commercial properties, and is especially true for non-


profit organiztions on limited budgets.

As many trusted servants realize, rents are steadily increasing and the costs associated with putting on meetings are also rising. New meeting places are ever more

difficult to find. It is therefore the responsibility of A.A. members to treat host venues with respect and to act in a responsible manner when it comes to building security and "housekeeping".

Many of the venues that host our meetings do so mainly because they support the work that A.A. is doing. When it comes to the rent A.A. pays, I would like to emphasize that the churches would make far more money renting to other groups who

> are always applying for space. Due to the brevity of our meetings, the rent charged can't be too high, but we never-the-less monopolize the available space for at least an hour before and after the meeting precluding other groups from us-



What I'm trying to say is that A.A. needs the churches (and other buildings) far more than they need us.

Below are experiences I had while caretaker of a church here in the city that was hosting about fifteen A.A. and other twelve step groups a week. Reports of similar incidents as those described below filter in to Central Office periodically. As a reminder to the Fellowship, we are rerunning this article (in a modified form) in the hope of raising awareness about a problem that reflects on A.A. as a whole.

The Problem

SECURITY – This is often the most contentious issue regarding A.A. use of a building. There have been many instances when doors were left unlocked, people were left in the building, and lights and appliances were left on. One group repeatedly, week after week, left the main entrance unlocked with no one else in the building. It wasn't until the building manager threatened them with eviction that they started taking their responsibility seriously.

Once, the main entrance was left unlocked and propped open onto the street and all the lights were left on after a night meeting. The new Secretary "didn't know where the light switches were" and "could've sworn I locked up". I know for a fact they didn't because luckily I arrived not 30 minutes after the meeting ended.

At one church, where I often attend meetings, items were stolen out of the parish hall on the night of a meeting. The Pastor subsequently called the meeting's Treasurer and even though it wasn't completely clear that A.A. was responsible, there was lingering bad feeling afterward. These are just a few of the examples

that I have experienced and heard about over the years.

The Solution

RESPONSIBILITY - It seems to me that it is up to the group Secretary (and other trusted servants) to insure that security measures are followed at the close of a meeting. This is particularly applicable to night meetings where it is unlikely that building personnel will be around. It's very important that everyone who comes in during the meeting is out before the doors are locked. This requires checking the bathrooms and other areas where people might be. It requires awareness on the Secretary's part to insure especially that those who come in during the meeting are there for the meeting and not to hide out in the church. This happens often and is the primary way that building security is jeopardized.

Often, a new coffee maker with less than a month of sobriety (and a very shaky commitment to A.A.) will be given the keys to a building and the responsibility of locking up. This practice is truly questionable and invites trouble. Why should the organizations that host our meetings be made vulnerable even if this practice is deemed good for someone's sobriety?

These issues can't be emphasized too strongly. Most people don't want to play policeman but it is our responsibility as good neighbors and community members to look out for the property we are entrusted with.

ACCOUNTABILITY is vital. When elections are held and trusted servants change, it is our responsibility to inform the host venue, provide telephone numbers, and establish rapport where possible. This is just basic courtesy. In some of the above-mentioned instances, the venues have had no idea who to contact. For night meetings when church personnel are not around this is a major issue.

Now that Central Office has on-line Trusted Servant registration capability that makes registering very easy, there really is no excuse why new trusted servants don't register. That way, when a venue calls Central Office with a complaint, Central Office will know who to contact. Pass the word on to your new trusted servants!

These issues as well as others that I don't have the space here to address (such as cigarette butts on sidewalks in front of entrances, loud motorcycles at night in residential neighborhoods, parking on sidewalks, trashed restrooms etc.) have come up continuously over the years.

This is the responsibility of A.A. as a whole; and that means *every person in a meeting* has the responsibility to make sure that our relations with others in the community reflect well on A.A. and that our primary purpose is theremised.

Pass the word!



Dear Alky:

I love college basketball and I can't wait for this year's March Madness. A group of work friends have invited me to a local sports bar for some of the games. I'd really like to go. I am not too worried about slipping. I have been in bars before and these are good friends who know I am in A.A. and are supportive of me staying sober. One suggested I could drink non-alcoholic beer while everyone else drank the real stuff so I didn't feel left out. It seems like an okay idea. What do you think?

Sports fan in A.A.

Dear Sports Fan:

You didn't really give me much information to go on, but it sounds as if perhaps you haven't yet gone through a March Madness sober before. In that case, Alky recommends staying out of the bars where you have spent your previous, drunken March Madnesses. (Is madnesses a word?) Drinking non-alcoholic beer in a bar during an activity in which you are accustomed to being wasted sounds like an awfully slippery place to me. Especially if you are doing so in an effort to avoid feeling "left out."

The Big Book tells us that we can go anywhere without fear, as long as we are in fit spiritual condition. But conventional wisdom in A.A., gathered from the experiences of many alcoholics over time, suggests that we should nonetheless not actually go looking for trouble. If you are indeed a relatively new member of the Fellowship, Alky suggests that you gather with fellow sober folk and watch the games together. Get rowdy with some beer-nuts, buffalo wings and caffeine. Start creating sober traditions around March Madness. You will feel much more a part of the fun when you are not checking out with booze. Good luck!

RESTRAINT OF TONGUE — CARRYING THE MESSAGE

In many meetings of Alcoholics
Anonymous throughout the San Francisco Bay area, it is common to hear members flavoring their shares with words and phrases that amount to what our society calls "swearing," "cursing" or "profanity." Often these are just garden-variety words that have become commonplace in our language. However, I sometimes hear words and phrases used in meetings that would have caused my mother to administer a soapy mouthwash to me had I been caught using them. I am

certainly no prude or zealot. At the same time, I confess that the occasional use of what I would call extreme vulgarity in meetings makes me uncomfortable – not for me personally, but because I wonder what the effect might be on other listeners.

I think first of the newcomer because, after all, that is who we are there for most of all. I ponder whether someone with a few days or even hours of sobriety; shaken, by Anonymous

scared, and already afraid that he or she is being asked to join a strange "cult", might be turned away by the freewheeling use of profanity - not to mention graphic descriptions of body parts and behaviors. I also consider the out-of-town visitor who might hail from a culturally very different part of the country or world. Will they come away from San Francisco A.A. with an appreciation for our diverse and open community, or will they go back home and tell their friends that

Herman B. attributes his sobriety to service within A.A. and also in the larger community. Originally involved in prison outreach through A.A. Hospitals & Institutions, today he brings prayer to prisons through his church. Q. Let's start with your sobriety date.

Sunshine Club.

A. Sobriety date is June 11, 1971. Actually, I had my last drink on the 8th, but I was kind of sick until the 11th. That's why I count from the 11th.

Q. How did you find out about A.A. in San Francisco?

A. Well, I started out 1970 with 30 days in jail and then I went straight back—got out at 10a.m. on a Saturday and by 3p.m. I was back in jail for being drunk. So I went before the judge again on Monday morning and he sentenced me to this Center for Special Problems, at Van Ness and Jackson. This was like a men's therapy group. So I was going there

and a guy in this group was in A.A.. To this day, I don't know why this guy picked me out of the group, he wanted to take me to A.A..

Q. Where was your first meeting in San Francisco?

A. It was the Night Owl group, it met at midnight on Saturdays, out at 1364 Valencia.

Q. So did you like it right off?

A. No. I managed to stay sober for 90 days and then I was back at it. It was strange, 90 days was the longest I could remember being sober. I was embarrassed. I had a brother that was 5 years older than me. When he was 30 I remember saying to him, "Brother, you're getting old." When I started coming out of a blackout at 34 years old, I didn't even remember being 30! I decided that, "You're a man with a new purpose and had survived for a reason." With booze I was destroying the one chance I had to have an intellect. So at that point I decided I wanted to live and that if I was going to live, the booze had to go.

Remember Jim from the Big Book who came to work on Tuesday? The Tuesday night Surf meeting is for the "Jim" in all of us. It's at 8 p.m. with easy access, great parking and one short block off 19th Avenue at Quintara. Jason the greeter will be out front to welcome you.

The Surf Meeting is reported to be the second oldest meeting in San Francisco. The Christ Lutheran Church meeting location was built in 1966 and the meeting has been housed there since the church was erected. The history is that at one time newcomers were sent directly from Central Office to this meeting. It was a reliably central location in San Francisco.

The meeting begins with the hammer of a gavel that has been passed down over the years. This gavel is inscribed with a plaque that says "Property of the Surf Group," and easily reflects its importance over its many years of use.

Roughly six years ago the meeting fell upon hard times. Bill, a regular member, says that that attendance dwindled down to six people with three from a local half-way house. The room was barren and sobriety was at risk. That was when Bill's sponsee, Patrick, became Secretary


and adopted the well-being of this neighborhood meeting. A General Service Representative was established and neighborhood members were encouraged to take on needed positions.

Every Tuesday there is an unofficial gathering of the "Knights of the Round Table" that meets at 6:30 p.m. before the regularly scheduled meeting. The "Knights" hold an open discussion about living in sobriety and how the twelve steps are integral in everyday life. It is attended by many of the locals as well as those new in sobriety. No one is asked to identify themselves as alcoholic or even consider their drinking history at these meetings. Little victories and bigger challenges are brought to the table.

The "Knights" began when the call went out from the Sheriffs
Department to get something together that targeted the more violent offenders at the jail over six years ago. The person who stepped up to the plate was an active A.A. member and he started RSVP (Recovery to Stop Violence Program) and the "Knights" was an outgrowth of that program. One member says, "This is an intense commitment and I love it." The group has been going strong ever

since with a core group of people in recovery committed to helping others.

The Surf Meeting is a speaker/discussion format. So, if your Monday plans go awry, this Tuesday night meeting can become a way to begin the week. Join them at 1090 Quintara St. /20th Avenue.

To me the bottom line on this topic is, of course, found in our Steps and Traditions. We are told to carry the message to other alcoholics and practice these principles in all our affairs. We are asked to carry our message through attraction. Does the free use of profanity in shares serve this purpose? I wonder. Surely there is a time and place for heartfelt, even colorful and passionate language in our meetings. But I can't help but

notice that such words do not appear in our book *Alcoholics Anonymous*, and that this book also urges us to practice "restraint of tongue and pen." As always, of course, such matters are for each individual A.A. to decide after consulting with their sponsor and their Higher Power.

C.H.A.O.S - Can't Handle **ANY OVERWHELMING** SITUATIONS

If you had to do all the things that I had to do, you'd drink too. My relief came in the way of Southern Comfort on the rocks. I was a mother of five, active in my community, driving a zillion carpools and had a husband addicted to his work. It was crazy making. Overwhelmed was my way of life.

I got lost in all the drama that surrounded me. My children were fighting with one another. I was fighting with my husband. He fought with the children. I fought with my children. Even our dog Fang (we thought the name was cute) barked at butterflies and most any other situation. Our adopted feral cat hid in the closet. My solution was to cultivate the loudest voice, coupled with hurtful phrases to shut out the opposition, and wash it all down with my favorite cocktails.

My first A.A. meeting was a shock. It was tranquility personified. I couldn't imagine that a group of individuals, alcoholics like I was, could sit quietly and listen to another person. No one interrupted. No one said, "What you need to do

is " No one got up to seek out a more interesting, prestigious group. People talked of craziness and they laughed.

I wanted to tell them how much of a victim I was. They told me to keep coming back. I wanted to talk about the drama of my life. They told me to keep coming back and maybe give Al-Anon a try.

Now after many years of program, my children still fight but they're older and they've had a steady dose of second hand A.A. I know they have a higher power that can be very influential in their life. That yappy dog has passed away, probably barking away in heaven. That addicted husband is now an exhusband and in program. My present husband tells me, "You're so wise." I don't tell him it is mostly A.A. talk.

I no longer have that need to prove myself or micro-manage anything. I'm not helpful to anyone unless they specifically ask for my help. Today, I can say, "No thank you," to all the drama. Overwhelmed is part of my history. tP

H & I COMMITTEE IN 2008

The beginning of Alcoholics Anonymous was founded by carrying the A.A. message from one alcoholic to another. When Bill W. and Dr. Bob searched hospitals to find the third member of A.A., they were also laying the foundation for what would later become part of the service work of the Northern California Hospital & Institution Committee. However, it wasn't until 1942 when the warden of San Quentin, Clinton Duffy, found that many of the inmates were there because of alcoholism. Subsequently, the first successful institution's meeting that we know of was held.

Today the Hospital & Institution Committee takes over 800 weekly meetings into facilities throughout Northern California. H&I currently goes into at least 22 major facilities including 19 California state prisons, such as San Quentin and Pelican Bay. These major facilities are in addition to the many local treatment and correctional facilities that H&I presently serves. Today, over 4,000 H&I volunteers provide service and A.A. meetings to alcoholics in these locked and restricted facilities.

Because the H&I Committee in Northern California predates the organization of General Service, and unlike many other parts of the United States, the Northern California H&I Committee is organized separately from our local General Service. While San Francisco and Marin counties are part of General Service Area 06, California Northern Coastal Area, the Hospital & Institution Committee encompasses both Areas 06 and 07 which covers all of Northern California along the coast from Humboldt County to Monterey and through the interior of California to the Nevada border. This is a huge undertaking - all supported by the contributions made to the Pink Cans available at most meetings of Alcoholics Anonymous.

Perhaps because the H&I Committee is organized separately from General Service, there has been some confusion about its finances and need for support. Pink Can contributions are used to provide A.A. literature to the many facilities that the committee serves. In addition, the H&I Committee provides speaker tapes through H&I volunteers to inmates and patients who can make use of them, and Pink Can contributions also support this project.

The H&I Committee has made greater efforts to communicate with the A.A. fellowship at large. In 2006, the Northern California H&I Committee conducted a group inventory as part of the committee's efforts to assess how it was doing, including communication with the fellowship as a whole. While its financial records have been readily available through its periodic newsletter, monthly financial statements provided by the H&I Committee are also available through our local Central Office, and, when possible, at the IFB meeting and San Francisco and Marin district General Service meetings. The H&I Committee recently conducted a survey, open to everyone, looking for suggestions regarding its website www.norcalhandi.org and is

Q So this was after you'd been sober for 90 days and then gone back out?

A. Yes, this was a year later. I was embarrassed to go back to A.A. because I wasn't just one of those guys who just leaves. I used to come to the meetings with bottles and say, "Look what I got!" [laughter] So I kind of snuck back in. I was living on Jones Street and they had this Ambassador's Group meeting at St. Boniface [Church] on Tuesdays. So

this guy came in and I was talking about doing something different this time and he invited me to this meeting at 1364 Valencia where he was the secretary, the Sixty Minute group. So I went out there on a Sunday and he threw me the keys and never said anything. said I could be the coffee maker.

Q. So you had a service commitment right away?.

A. After about three or four months, he changed shifts on his job, he was a

waiter. So he said he would make the coffee because he lived nearby and I could be the secretary and he would help me get the speakers. I thought he was nuts. People didn't think I could talk then, I was very quiet,

Q. How did meetings in the early 70's differ from meetings today?

A. There was no holding hands, there was no hugging and there was lots of smoking!

Writing As A Tool For Recovery

"When evening comes, perhaps just before going to sleep, many of us draw up a balance sheet for the day. This is a good place to remember that inventory-taking is not always done in red ink. It's a poor day indeed when we haven't done *something* right." (Twelve Steps and Twelve Traditions)

I am a writer and an alcoholic. For years I tried to guit drinking. In my journal I wrote about each time I quit as a moment to be recorded for posterity. Who cared about the day when I quit drinking and using for good? My kids? Those little babies who were in their car seats in the back when I was driving drunk? Those toddlers who I screamed at when their shrill voices pierced my hangover headache? I am glad I wrote about my drinking and quitting. I want to remember what I was like.

Now that I am sober I write down the good things in my life and in me. The Twelve and Twelve reminds me that an inventory shouldn't be taken all in red ink. I get to write down the good stuff that I do as well. Yes, I need to inventory my resentments and my fears, but I can also list my gratitude and my good deeds each day.

When I first got sober in 1986, I didn't Inwardly I groaned. Oh no, another want to do what you people told me to. I write for a living, why should I have to write to stay sober? Can't I just think about my Fourth Step and then tell my sponsor? Preferably over the phone? Nope – put pen to paper. Amazing what comes out once you start to write. It took me several months to write, but I read it to my sponsor and we completed Step Five.

I had to write again when one of my children was stricken with a serious illness. There was no treatment, just watchful, fearful waiting. I asked my sponsor what to do. Her mother had been critically ill, near death, soon after we started working together. She knew how to cope with a crisis. "Maybe you could try writing a letter to God . . . ", she said. I put pen to paper, "Dear God, I hate you for what you are doing to my daughter." Admitting to myself how angry and afraid I was helped me share at meetings and ask for support. At a big meeting the speaker, as we stood holding hands in a circle, asked our Higher Power, "to help the member whose child is having trials."

I got another hint in a noon meeting near my work. A man said that he kept a notebook on his bedside table and wrote a Tenth Step every night.

suggestion. But it is an easy practice. I write down the good things I did during the day and the nice things other people did for me. I am amazed how many good people there are in the world and that I am often one of them. If I owe an apology or an amends I write it down. That helps to imprint it on my brain, so I remember to take care of it as soon as possible.

Then a sponsee mentioned that she writes a gratitude list every morning and it really makes her day go smoother. Here we go again! So I started trying to write a daily gratitude list. She wasn't the only person who mentioned gratitude lists. My Higher Power sometimes needs to repeat what I need to hear. When I write down that I am grateful for my sobriety, health, family, job and home, I am more likely to notice the person in the wheelchair and to be grateful for my feet, even if they do ache.

When I write I am not just talking to myself; I am talking to the Higher Power within me. I am opening up my mind and my heart to new ideas and the possibility of changing my life, with the help of the Steps and the tP of Alcoholics fellowship Anonymous.

Following is an unofficial summary of actions, information, upcoming business and service opportunities discussed at the February 2008 IFB meeting. IFB Reports

Chair's Report: Chuck K. gave his report.

The future dates for IFB meetings in Marin have been confirmed to prevent the same mistake that happened with this month's meeting. The new Fellowship Committee has been formed and is meeting. He also met with the Access Committee to facilitate their work with the IFB and COC. More Rep reports concerning the issue of dual-named meetings have been received and reviewed.

Treasurer's Report: Patrick M gave the

report. For the month of December, the Net Income was \$16,208, which was \$11,091 better than the budgeted surplus of \$5,117. For YTD thru December, Net Income was \$27,313 which was \$27,313 higher than the budgeted breakeven. The favorable result in December was due to higher contributions and Gratitude Month than budgeted, partially offset by higher expenses. Total expenses for the month of (Continued on page 17)

October were \$1,565 higher than budget. The higher expenses were due to higher computer consulting, office supplies and repairs and maintenance. The improvement in YTD net income is primarily due to higher contributions and lower expenses (primarily Access Expense).

2008 Budget Update: The 2008 budget assumed a +4% increase for group contributions. Income was +7.4%, so there should be plenty cushion in 2008 in case income falls short of budgeted expectations.

Bank Accounts: Total checking and saving account balances were \$195,604 as of the end of December, of which \$57,810 is unrestricted cash and \$37,794 is restricted cash. We have another 6 months of operating expenses in our Prudent Reserve (part of restricted cash).

Central Office Report: Peter M. gave the report in Maury's absence. Congratulations to Maury on her new son born on Jan. 11, 2008! New schedules are now available. *The Point* mailing costs were greater than usual due to its mailing size. Already nearly 40 people have registered as Trusted Servants online. Help is needed with graphics experience to develop a CD label for our CD lending library.

Central Office Committee Report: The COC report was given by Ken J.

12th Step Committee: NR.

Archives Committee: Bruce K. reported on the on-going preservation of historical AA materials.

Orientation Committee: Patty M. reported on the orientation meetings held before the monthly IFB meetings. Ron M. will be the new committee chair as of July 2008.

Trusted Servants Workshop Committee: Patty M. reported that the committee discussed the 2008 schedule of workshops. A Treasurer's handout has been put together, based on a selection of pamphlets and excerpts from AA literature. Other handouts are being developed. Patty will be stepping down as chair of the committee in June and a volunteer is needed to replace her.

Website Committee: Michael P. reported on the Online Trusted Servant Registration system, the new meeting search features including the ability to link for directions and mapping, and the ability for anyone accessing the site to create their own personalized list of meetings. Compliments for the committee's work were offered by the IFB Reps.

Teleservice, Marin: Paige J. reported that the committee recently submitted its proposed changes to their website to Marin General Service, and she mentioned the possibility of linking the Marin Telservice website to the Central Office website.

OUTCOME RATES IN A.A. -A NEW STUDY . . .

The Point Committee thought this might be of interest to our readers even though the study was not done by San Francisco or Marin members. We don't have room to publish the entire study but links to it are provided after this introduction. We hope you enjoy it as much as we did.

"This paper addresses an erroneous myth that AA is experiencing a 5% (or less) "success rate" today as opposed to either a 50%, 70%, 75%, 80% or 93% (take your pick) "success rate" it once reputedly enjoyed in the 1940s and 1950s. The term "myth" is used to emphasize that the low "success rates" promulgated are a product of imagination, invention and inattention to detail rather than fact-based research."... "Consequently, much effort has been taken to ensure that the contents of this paper are independently confirmed in reliable written reference sources. Those sources are identified in footnotes or in the body of the narrative."

"This paper is written for AA members and is intended for internal and public circulation as an item of AA historical and archival research. It is offered to help inform the AA membership and academic researchers of a widely circulated misinterpretation and mischaracterization of AA recovery outcomes.


